SUMMARY:
The Elections Code specifies that the Registrar of Voters shall prepare a Certified Statement of Results of the Election and submit it to the governing body with the duty of canvassing the results of the election, which for a consolidated local election is the Board of Supervisors. The governing body shall declare elected or nominated to each office voted on at each election under its jurisdiction the person(s) having the highest number of votes for the office as provided by law. The governing body shall also declare the results of each election under its jurisdiction as to each measure voted on at the election. Reference: Elections Code §§ 8140, 8141, 10412, 15372, and 15400.

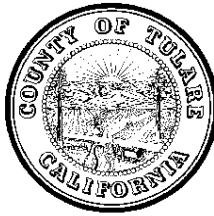


