**DECLARING AUGUST 2016 AS
CHILD SUPPORT AWARENESS MONTH
IN TULARE COUNTY**

WHEREAS, the vision of the Tulare County Department of Child Support Services is that children can count on both parents for the financial, medical, and emotional support they need to be healthy and successful; and

WHEREAS, the purpose and mission of the Tulare County Department of Child Support Services are to enhance the well-being of children by assuring that assistance in obtaining support, including financial and medical, is available to children through locating parents, establishing paternity, establishing support obligations, and monitoring and enforcing those obligations; and

WHEREAS, more than 25,800 children benefit each year from services provided by the Tulare County Department of Child Support Services, with approximately \$38 million in child support expected to be collected and distributed in Federal Fiscal Year ending September 30, 2016, enabling children to grow up in a healthy environment where they receive the financial, medical, and emotional support they need from both parents is among the department's highest priorities; and

WHEREAS, August 2016 has been selected as Child Support Awareness Month in the State of California.

NOW, THEREFORE, BE IT RESOLVED, that the Tulare County Board of Supervisors does hereby proclaim August 2016 as "Child Support Awareness Month" in Tulare County.
