SUBJECT: Approve an amendment to Agreement 26196 with Cutler-Orosi Unified School District.

REQUEST(S):

That the Board of Supervisors:

1. Approve an amendment to Agreement 26196 with Cutler-Orosi Unified School District, to extend the term of the agreement to June 30, 2017 in the amount of \$98,688 for providing a school resource officer on district campuses. The amendment is retroactive due to a delay in the Cutler-Orosi School board signing the amendment.
2. Find that the Board had the authority to enter into the proposed amendment as of July 1, 2016, and that it was in the County's best interest to enter into the agreement on that date.
3. Authorize the Chairman to sign four copies of the amendment.

SUMMARY:

Cutler-Orosi Unified School District is seeking to continue to partner with the Sheriff's Department to provide a Sheriff's deputy to serve as a school resource officer on district campuses.

Under the contract, the deputy provides a visible law enforcement presence on campus; assists school officials in enforcing school attendance laws; utilizes intervention and prevention skills with students who are involved in criminal activity; acts as a resource deputy for school personnel; and provides classroom

instruction on law enforcement issues, such as gang awareness.

The original agreement was approved as to form by County Counsel and approved by the Board of Supervisors on July 30, 2013. The substantive deviation from the standard County boilerplate included in the original agenda item was: indemnification is mutual. The proposed amendments to the agreement do not include any additional deviations from the standard County boilerplate.

The only changes from the original agreement, as amended to date, are extending the term of the agreement through June 30, 2017, and updating the budget (Exhibit A-3).

FISCAL IMPACT/FINANCING:

The Sheriff's Department will be compensated \$98,688 by Cutler-Orosi Unified School District for the salary, benefits, and operating costs for the school resource officer. Funds are included in the Sheriff's Fiscal Year 2016/2017 budget. There is no net County cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes Initiative 1: Safety and Security and Initiative 2: Quality of Life. This amendment supports these initiatives by collaborating with school districts, cities and community-based nonprofit organizations to promote early intervention for at-risk youth; and by encouraging innovative provision of quality supportive services for at-risk youth.
