**SUBJECT:** Approve an Amendment to the Agreement with Alternative Services, Inc.

**REQUEST(S):**  
That the Board of Supervisors:

1. Approve the amendment to agreement no. 27223 with Alternative Services, Inc. in the amount of \$208,000 per year to provide Alcohol and Drug counseling services for the Residential Substance Abuse Treatment program from July 1, 2017 through June 30, 2018.
2. Authorize the Chairman of the Board to sign the Agreement.

**SUMMARY:**  
Alternative Services, Inc. is the contracted agency providing services for the Residential Substance Abuse Treatment (RSAT) program. This grant program is funded by the Board of State and Community Corrections (BSCC). Provides services to 64 men housed at MCF who have identified substance abuse issues.

The original agreement was approved as to form by County Counsel and was approved by the Board of Supervisors on June 30, 2015. The original agreement did not include any terms that substantively deviated from the standard County contract boilerplate. The proposed amendment to the agreement does not include any substantive deviations from the standard County contract boilerplate.

The only changes from the original agreement, as amended to date, are changing the time period of the agreement to extend the term to June 30, 2018, and increase the dollar amount to be paid under the agreement to \$208,000 per year."

**SUBJECT:** Approve an Agreement with Alternative Services for the RSAT program.  
**DATE:** June 27, 2017.

**FISCAL IMPACT/FINANCING:**

The amount of the agreement is \$208,000. The general fund will be reimbursed from the Inmate Welfare Trust Fund and/or through BSCC grant funding, resulting in no Net County Cost. This expenditure will be included in the Sheriff's 2017/2018 operating budget.

**LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:**

The RSAT grant clearly is in alignment with the Safety and Security initiative of the Strategic Business Plan. More specifically it addresses the goal to "Provide facilities and resources for training and rehabilitation of criminal offenders." Counselors work with inmates on a full-time basis addressing the life skills and tools necessary for planned reentry into the communities.
