**SUBJECT:** Approve an Amendment to Agreement No. 25986 with the PAAR Center.

**REQUEST(S):**

That the Board of Supervisors:

1. Approve an Amendment to Agreement No. 25986 with PAAR Center, retroactive to July 1, 2017, in the amount of \$350,000 per year to extend the term of the agreement to June 30, 2018. The amendment to the agreement is retroactive due to the date the amendment was received from the vendor.
2. Find that the Board had the authority to enter into the proposed agreement as of July 1, 2017, and that it was in the County's best interest to enter into the agreement amendment on that date.
3. Authorize the Chairman to sign four (4) copies of the amendment.

**SUMMARY:**

The PAAR Center is a non-profit, community-based facility located in Porterville, California, designed to assist those struggling with alcohol and drug addiction. The PAAR Center is currently the only facility in the Porterville area that provides residential and outpatient services to both men and women. A major goal of the PARR Center is to provide quality treatment, supervision and case management services to qualifying participants.

The Probation Department has an established relationship with the PAAR Center, which has provided residential and outpatient services to adult probationers; and to offenders defined in AB 109: those released on Post-Release Community Supervision

**SUBJECT:** Approve an Amendment to Agreement No. 25986 with the PAAR Center.  
**DATE:** August 8, 2017

(PRCS) and those subject to an alternative sentence pursuant to Penal Code Section 1170(h).

The original agreement was approved as to form by County County Counsel on February 13, 2013 and approved by the Board of Supervisors on February 26, 2013. It was subsequently amended by Agreement No. 25986-A on June 25, 2013, Agreement No. 25986-B on November 12, 2013, Agreement No. 25986-C on May 20, 2014, Agreement No. 25986-D on September 29, 2015 (Approved by County Counsel September 9, 2015), and Agreement No. 25986-E on June 14, 2016 (Approved by County Counsel May 12, 2016).

The proposed amendment to the agreement does not include any terms that substantively deviate from the standard County boilerplate.

**FISCAL IMPACT / FINANCING:**

The anticipated cost for services during Fiscal Year 2017/2018 is \$350,000, which is included in the Fiscal Year 2017/2018 requested budget. The costs associated with the agreement are offset from revenue received from SB 678 and AB 109 funding. There are no net County costs.

**LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:**

The County's five-year strategic business plan includes the Safety and Security initiative that provides for the safety and security of the public. The approval of this agreement helps fulfill this initiative by contracting with the PAAR Center for community-based services geared towards the rehabilitation of low-level offenders.
