SUBJECT: Approve a Capital Asset purchase of two vehicles

REQUEST(S):

That the Board of Supervisors:

- 1. Approve a capital asset purchase of two vehicles in an amount not to exceed \$44,000.
- 2. Approve the necessary budget adjustments per the attached AUD 308 (4/5ths vote required.)

SUMMARY:

The Public Defender Department requests the purchase of two Toyota Corollas to be used by the Investigators and Social Workers in an amount not to exceed \$44,000. In January 2018, the Public Defender Department transferred two vehicles to the Tulare County Purchasing Department to be disposed of through the County surplus program. The vehicles required extensive maintenance and repairs to remain in operation. The department is requesting authority to purchase two Toyota Corollas to replace the two vehicles.

Public Defender Investigators and Social Workers are assigned County vehicles. Investigators use the assigned vehicles daily to investigate criminal matters referred to the Public Defender's office and to gather evidence and testimony for presentation in court. Social Workers also conduct investigations to develop and prepare evidence to be presented in court and other client services.

SUBJECT: Approve a Capital Asset purchase of two vehicles

DATE: March 6, 2018

FISCAL IMPACT/FINANCING:

The Public Defender Department will use salary savings from attorney vacancies in positions #07848 and #07852, in the amount of \$44,000 to fund the purchase of the two vehicles. The AUD 308 will adjust expenses from salary lines to appropriate funds for the purchase of the vehicles. There is no Net County Cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year Strategic Business Plan and Management System include Safety and Security initiatives to provide for the safety and security of the public. This purchase will help fulfill this initiative.
