**SUBJECT:** Approve an agreement with the California Office of Emergency Services.

**REQUEST(S):**

That the Board of Supervisors:

1. Rescind prior approved Agreement No. 28426, Resolution No. 2017-1010, and recognize the attached agreement, once countersigned, as the binding agreement.
2. Approve an agreement with the California Office of Emergency Services in the amount of \$610,361 for the Victim/Witness Assistance Program, for the period October 1, 2017 through September 30, 2018. This agreement is retroactive due to the funding agency's late release of the request for application and our recent decision to request the full amount allocated.
3. Find that the Board had authority to enter into the proposed agreement as of October 1, 2017, and that it was in the County's best interest to enter into the agreement on that date.
4. Authorize the Chairman to sign the Grant Subaward Face Sheet and the Subrecipient Grants Management Assessment.
5. Authorize the Chairman and the County Administrative Officer to sign the Certification of Assurance of Compliance.

**SUMMARY:**

On December 12, 2017, your Board approved Agreement No. 28426 (Resolution No. 2017-1010) with the California Governor's Office of Emergency Services (Cal OES) for the Victim/Witness Assistance Program (VW Program), for fiscal year

2017/2018. The application was submitted requesting \$498,031; however, Cal OES has given us an opportunity to re-submit for full funding in the amount of \$610,351 which will allow the District Attorney to cover additional operational costs.

Fiscal year 2017/2018 funding will cover the salaries and benefits of five full-time Victim Witness Workers, 35% of the Victim Witness Worker Supervisor, and 35% of the District Attorney Program Manager and 100% of the salary of an Extra Help Victim Witness Worker. This additional funding gives us an opportunity to cover costs for operational items we normally would not be able to provide, including an emergency fund to provide immediate housing, food and clothing to crime victims, as well as funds to pay for a pro-rated share of a forthcoming new case management system.

The total funding includes \$488,281 in federal Victims of Crime Act funds, \$98,203 in state Victim Witness Assistance funds, and \$23,867 in local match funds. These new totals make it necessary to obtain a signature on the attached revised grant subaward face sheet.

We are also asking that the Board rescind Resolution No. 2017-1010 approving the previous agreement, and recognize this agreement in the amount of \$610,361, once countersigned, as the final agreement. This new agreement reflects only a change in the amount of the award. The terms and conditions remain the same.

This agreement has been approved as to form by County Counsel. The following terms deviate substantively from the standard County boilerplate:

1. County must indemnify State;
2. State may terminate immediately for cause;
3. County must sign first;
4. Department of Justice may terminate immediately for cause;
5. County must allow timely and reasonable access to records pertinent to the award for at least 3 years after submission of final expenditure report, and as long as the records are retained thereafter;
6. County may only impose federal record retention requirements as described in 2 C.F.R. 200.333 on any sub recipients of award funds; and
7. Agreement is contingent on availability of funds.

**FISCAL IMPACT/FINANCING:**

The total program budget is \$610,351, which includes \$586,484 in grant funds and \$23,867 in matching funds. Expenses and revenues were included in the District Attorney's FY 17/18 adopted budget. There is no additional Net County Cost associated with this agreement, as the \$23,867 in matching funds will be covered by savings in our operational budget.

The Subrecipient understands and agrees that it cannot use any federal funds, either directly or indirectly, in support of any contract of subaward to either the ACORN or its subsidiaries, without the expressed prior written approval of OJP.

19. Access to Records

The Subrecipient authorizes the Office for Victims of Crime (OVC) and/or the Office of the Chief Financial Officer (OCFO), and its representatives, access to and the right to examine all records, books, paper or documents related to the VOCA grant.

20. Nondiscrimination in Programs Involving Students

The Subrecipient understands and agrees that award funds may not be used to discriminate against or denigrate the religious or moral beliefs or students who participate in programs for which financial assistance is provided from those funds, or of the parents or legal guardians of such students.

All appropriate documentation must be maintained on file by the project and available for Cal OES or public scrutiny upon request. Failure to comply with these requirements may result in suspension of payments under the grant or termination of the grant or both and the Subrecipient may be ineligible for subaward of any future grants if the Cal OES determines that any of the following has occurred: (1) the Subrecipient has made false certification, or (2) violates the certification by failing to carry out the requirements as noted above.
