REQUEST(S):

That the Board of Supervisors:

- 1. Approve a Memorandum of Understanding with the Laura and John Arnold Foundation to implement the Public Safety Assessment[™] court-based pretrial risk assessment tool.
- 2. Authorize the Chairman to sign three (3) copies of the Memorandum of Understanding

SUMMARY:

The Laura and John Arnold Foundation ("Foundation") is a tax-exempt private foundation dedicated to producing substantial, widespread, lasting reforms that will transform the criminal justice system. This Memorandum of Understanding ("MOU") concerns the collaboration between the Foundation and the County on a project to implement the Public Safety Assessment™ court-based pretrial risk assessment tool developed by the Foundation.

The Foundation and the County share the goals of increasing public safety, reducing crime, and improving the cost-effectiveness and fairness of the criminal justice system. The County and the Foundation intend to collaborate on the implementation of the Public Safety Assessment™ tool, as well as the collection and evaluation of related data, in order to enhance the administration of criminal justice in the County and nationally. In furtherance of this goal, the Foundation is granting the County, a nonexclusive, non-transferable right and license to install, implement, and use the Tool free of charge in the County, provided that the County

abide by all the terms and conditions of this MOU.

It is the intent of the County to administer the Public Safety Assessment[™] tool to defendants pending court proceedings and develop and an implementation plan.

County Counsel has approved the MOU as to form. The noted following terms deviate from the standard County boilerplate:

- 1. Term is evergreen, but allows for either party to terminate immediately with written notice, with or without cause.
- 2. County must indemnify Foundation.
- 3. The Foundation is not liable for the County's use of the free tool.
- 4. Both parties are prohibited from assigning without written permission from the other party.

FISCAL IMPACT/FINANCING:

There is no net County cost to the General Fund. The Foundation is granting the County a nonexclusive, non-transferable right and license to install, implement, and use the Public Safety Assessment™ tool free of charge in the County, provided that the County abide by all the terms and conditions of the MOU.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic business plan includes the Safety and Security initiative that provides for the safety and security of the public. The Foundation and the County share the goals of increasing public safety, reducing crime, and improving the cost-effectiveness and fairness of the criminal justice system. This collaboration between the County and the Laura and John Arnold Foundation on the implementation of the Public Safety Assessment™ tool, as well as the collection and evaluation of related data, intends to enhance the administration of criminal justice in the County.
