 Approve the budget adjustment of \$38,860 resulting from an EDD modification to Subgrant Agreement Number K8106694 to provide employment training activities for youth involved in the justice system (4/5ths vote required).

SUMMARY:

EDD has modified Subgrant Agreement Number K8106694 (Resolution No. 2017-0749) to include \$200,000 to provide employment training activities for youth involved in the justice system. The time frame for this modification is 02/01/2018 through 06/30/2019. The remaining funds of \$161,140 will be included in the FY 2018/19 budget.

FISCAL IMPACT/FINANCING:

The program is financed with federal funds. The Workforce Investment Board's operating budget will increase by \$38,860. There is no cost to Tulare County.
