Remodel Project

REQUEST(S):

That the Board of Supervisors:

- 1. Award contract for the Health and Human Services Agency Farmersville Remodel Project to the lowest responsible bidder, Gary Interrante Construction Co., in the amount of \$114,800.
- Authorize the Chairman to sign the construction agreement upon receipt of certificates of insurance, bonds, license verification, and contract, subject to review and approval as to form by County Counsel.

SUMMARY:

On February 27, 2018, the Board authorized the advertisement of bids for the Health and Human Services Agency (HHSA) Farmersville Remodel Project, 907 W. Visalia Rd, Farmersville, CA 93223. The Project consists of interior renovations to an existing building formerly occupied by County Fire Administration as the Emergency Operations Center (EOC). The work includes, but is not limited to the following: select partial demolition, site improvements, paint, carpet, and finishes.

A total of two (2) bids were received and opened on March 29, 2018. A recap of the bids is as follows:

The contract documents call for 60 calendar days of construction.
