### SUBJECT:

Month-to-month extensions to Agreement No. 24367 as amended with MV Transportation Inc. for Transit Services

### REQUEST(S):

That the Board of Supervisors:

- Approve three (3) month-to-month extensions for the months of July 2018, August 2018 and September 2018 to Agreement No. 24367 as amended with MV Transportation, Inc. to extend the term of the agreement from July 1, 2018 to September 30, 2018; and
- 2. Authorize the Chairman, or his designee, to sign the three (3) month-tomonth extensions to the Agreement for July 2018, August 2018 and September 2018; and
- Authorize the Resource Management Agency Director, or his designee, to notify MV Transportation, Inc. of the extensions under Article 12.2 of Agreement No. 24367.

### SUMMARY:

Tulare County Area Transit (TCaT) provides rural and intercity transit services between, in, and around various cities and communities within the County. These services include fixed-route buses, demand response (Dial-A-Ride) services, and the LOOP Bus.

Since its inception, the County transit service has been operated by contract vendors. The County's current vendor, MV Transportation, Inc., has managed TCaT services since 2006. In 2009, MV Transportation was awarded a service contract (Agreement No. 24367) through a competitive bid process for the period

**DATE:** May 22, 2018

January 1, 2010 to June 30, 2012. This contract provides two three-year options to mutually extend the agreement an additional six years through June 30, 2018.

In December 2017, Tulare County Area Transit staff prepared in conjunction with the City of Visalia, City of Tulare and the County of Kings a Request for Proposal (RFP) for the transit operations. Resource Management Agency staff are negotiating with the preferred proposer but do not anticipate that an agreement will be reached therewith by June 30, 2018, as the coordination and services require coordination with the City of Visalia and City of Tulare to try to share services or management and thereby save operating costs. As such, staff are requesting the Board exercise its option under Section 12.2 of Agreement 24367 as amended to extend the agreement on a month-to-month basis for the first three months to allow time for additional negotiation with the proposer.

### FISCAL IMPACT/FINANCING:

There will be no Net County Cost to the General Fund.

The expenses under the first three month-to-month extensions are estimated to be approximately \$481,009 for the three-month period from July 1, 2018 through September 30, 2018. These funds will be paid out of the transit fund, which will use one of the various sources of state or federal funding, such as FTA Sec 5311 funding or State Transit Assistance funding, designated for use for public transit. These extensions are at the same rate as the prior fiscal year. These expenses would otherwise be paid under the forthcoming transit contract.

### LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The Strategic Business Plan includes the Safety and Security strategic initiative, which includes a goal to improve and maintain an adequate transportation infrastructure. These extensions would help the County maintain public transit services for the term of their extension.
