### REQUEST(S):

That the Board of Supervisors:

- Approve Amendment No. 6 to Agreement No. 27894 with Forcum Mackey, Inc. to increase the agreement amount by \$27,581.06, from \$4,296,616.72 to \$4,324,197.78 for Phase I of the Countywide Space Improvement & Relocation Project.
- 2. Increase the contract time by 17 calendar days for County Counsel Bid Package C.
- 3. Authorize the Chairman to sign the Agreement Amendment.
- 4. Authorize the Chairman of the Board of Supervisors to sign the Notice of Completion for County Counsel Bid Package C, subject to review and approval as to form by County Counsel.
- 5. Direct the Clerk of the Board of Supervisors to record the Notice of Completion for County Counsel Bid Package C with the office of the Tulare County Recorder.

### SUMMARY:

On November 15, 2016, the Board approved Agreement No. 27894 in the amount of \$3,117,000 with Forcum Mackey, Inc. to provide construction services for Phase I of the Countywide Space Improvement and Relocation Project in Visalia, California. The construction project consisted of renovations to three existing office buildings: the Tulare Akers Professional Center, the new Human Resources & Development (HRD) Building, and the County Counsel Building.

SUBJECT: Amendment No. 6 to Agreement 27894 with Forcum Mackey and Notice of Completion DATE: June 12, 2018

Forcum Mackey, Inc. was awarded all three projects. The HRD, Sheriff and Fire, and County Counsel projects were completed in June of 2017, September of 2017, and March of 2018 respectively. The following table summarizes all subsequent amendments to the project amount and timeline, including the proposed sixth amendment.

### FISCAL IMPACT/FINANCING:

The project is funded in the Capital Projects Fund (030-086-3200-8127). Many of these costs are necessary to relocate the Departments and would have been more costly to the County if they were undertaken at a future date while the Departments were occupying this space. The project's change order contingency and savings from the furniture purchase will cover these additional costs.

The County's Strategic Business Plan includes the Organizational Improvement initiative. This project will ensure that several departments have the necessary functional spaces to achieve their mission and serve their customers.
