

SUBJECT: Notice of Completion for Construction of the Avenue 416 Widening Project

REQUEST(S):

That the Board of Supervisors:

- 1. Accept the work for the construction of the Avenue 416 Widening Project as complete by Yarbs Grading and Paving, Inc. of Fowler, California; and
- 2. Authorize the Chairman to sign the Notice of Completion; and
- 3. Direct the Clerk of the Board to have the Notice of Completion recorded with the County Recorder.

SUMMARY:

This Notice of Completion is for the construction of the Avenue 416 Widening Project. This project was completed on schedule and under the allowable budget. The work was performed by Yarbs Grading and Paving, Inc. under Tulare County Agreement No. 27827.

This project was approved by your Board on June 28, 2016. The lowest responsible bid was submitted by Yarbs Grading and Paving, Inc. On September 13, 2016, your Board awarded and approved (Resolution No. 2016-0763) a contract to Yarbs Grading and Paving, Inc. of Fowler, California in the amount of \$8,621,265.

This project consisted of widening Avenue 416 to a four lane roadway with center median and turn lanes between Road 32 and Road 56. This project also included the improvement of five intersections located along Avenue 416. This project was a portion of a larger joint effort between the Counties of Tulare and Fresno, the City of Dinuba and Caltrans. With the completion of this project, Avenue 416 has been widened to four lanes between Road 80 and State Highway 99.

There were twelve Contract Change Orders (CCO) written for this project with a net total cost of \$261,236.24. The summary of the CCO's written for this project is summarized in Attachment C.

An allowance of 5.29% of the contract bid amount, or \$456,064, was authorized for contingencies at the time of project approval setting the total approved contract amount at \$9,077,329.

The final project cost to complete this project was \$7,744,283.78 which is 10.17% below the bid amount and is 14.69% below the authorized contract amount plus contingencies.

The completed project resulted in cost savings of approximately \$1.1 million. This cost savings came primarily as a result of the Contractor utilizing an asphalt supplier which produced lighter weight asphalt concrete material than other local suppliers. The reduction in unit weight for asphalt concrete resulted in an overall decrease in the bid item for Hot Mix Asphalt Concrete needed to construct the project, thus leading to a cost savings of approximately \$550,000. Furthermore, this project included a supplemental item to account for increases to the statewide crude oil index. Throughout construction the minimal increase in crude oil pricing resulted in an approximate cost savings of \$430,000 from the amount originally set aside. These items, in addition to Contractor's chosen construction methods, resulted in the overall cost saving mentioned above.

This project has been completed in accordance with the plans and specifications and is now ready for acceptance by the Board.



Contract Change Order No. 1

Installed 42-inch Ductile Iron Pipe instead of 48-inch Reinforced Concrete Pipe for the replacement of the McBriar Pipeline.

Total cost for this CCO = \$23,568.97

Contract Change Order No. 2

Installed 53 linear feet of 18-inch Reinforced Concrete Pipe as well as relocate an existing chain link swing gate to re-establish access to a property owner.

Reimbursed the Contractor for making a direct payment to Pacific Gas and Electric Company (PG&E) to provide electrical service connections for the proposed traffic signals along Avenue 416.

Total cost for this CCO = \$18,432.17

Contract Change Order No. 8

Constructed additional drainage improvements adjacent to the Kings River Bridge abutments.

Total cost for this CCO = \$37,422.00

Contract Change Order No. 9

Installed new crash cushion systems at each end of the median barrier over the Kings River Bridge.

Total cost for this CCO = \$96,800.00

Contract Change Order No. 10

Compensated the Contractor for additional work performed by Madco Electric for additional work associated with the signals and street lighting.

Total cost for this CCO = \$10,112.50

Contract Change Order No. 11

Compensated the Contractor for cost associated with upgrading traffic signal pull boxes.

Total cost for this CCO = \$27,214.00
