SUBJECT: Approve an Agreement with the California Department of Food and Agriculture regarding Nematode Inspections for Fiscal Year 18/19.

REQUEST(S):
That the Board of Supervisors:

1. Approve an Agreement with the California Department of Food and Agriculture, to provide funding of \$1,125.00 to offset the costs of providing soil and commodities treatment supervision and/or nematode sampling for the California Department of Food and Agriculture for July 1, 2018 through June 30, 2019.
2. Authorize the Chairman to sign two copies of the Agreement.

SUMMARY:
This Agreement is intended to render financial aid to the County to provide soil and commodities treatment supervision and/or nematode sampling for the California Department of Food and Agriculture. These services will insure that nurseries within the County are free from the presence of harmful nematodes, protecting the marketplace and the nursery industry of Tulare County.

This agreement has been approved as to form by County Counsel. The following terms deviate substantively from the standard County boilerplate:

- 1) Neither party to the agreement will indemnify the other.


FISCAL IMPACT/FINANCING:

No additional net county cost to the General Fund. The County will receive funding up to \$1,125.00 for Fiscal Year 2018/2019 from the California Department of Food and Agriculture. Revenues and the associated expenditures for this program will be included in the Agricultural Commissioner/Sealer's Fiscal Year 2018/2019 budget.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Economic Well-Being Initiative to promote economic development opportunities, effective growth management, and a quality standard of living. This request to authorize an Agreement with the California Department of Food and Agriculture for the purpose of providing soil and commodities treatment supervision and/or sampling will insure that nurseries within the County are free from the presence of harmful nematodes, protecting the marketplace and the nursery industry of Tulare County. This serves to protect the County's agriculture-based economy by providing a safeguard for the nursery industry.
