I. PURPOSE

Addendum No. 1 to the Tulare County Human Trafficking Task Force Memorandum of Understanding (hereinafter, “the original MOU”) will add the Tulare Police Department as a key member of the Tulare County Human Trafficking Task Force, under Section II of the original MOU. All other provisions of the original MOU shall remain in effect.

The Tulare Police Department agrees to participate in the FY 2016 Enhanced Collaborative Model to Combat Human Trafficking program, jointly funded by the Bureau of Justice Assistance and Office for Victims of Crime as outlined in the original MOU.

II. PARTNER AGENCY ROLES

Working toward the three goals outlined in the original MOU, the Tulare Police Department hereby commits to the following:

- Commit key staff to actively participate in both the quarterly Coalition and monthly Task Force meetings;
- Provide information to the Task Force on pending and planned cases;
- Provide assistance with planned undercover cases and rescue efforts;
- Identify a law enforcement liaison or designee as a point of contact for Task Force activities;
- Said law enforcement liaison will report all statistical data to the Task Force coordinator in a predetermined format; and
- Leverage other program funding to meet the goals and objectives of the Enhanced Collaborative Model to Combat Human Trafficking program.






