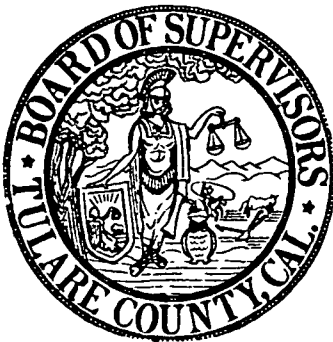

SUBJECT: Amend Agreement No. 27574 with Bernards Bros., Inc.

REQUEST(S):

That the Board of Supervisors:

1. Approve an amendment to Agreement No. 27574 with Bernards Bros., Inc. to increase the agreement amount by \$45,832 from \$52,560,240 to \$52,606,072.
2. Authorize the Chairman to sign the Agreement Amendment.

SUMMARY:

On April 19, 2016, the Board approved Agreement No. 27574 with Bernards Bros, Inc. to provide construction services for the South County Detention Facility in Porterville, California. The awarded contract amount was \$52,442,000. The Board has previously approved three change orders in the amount of \$118,240. The current contract amount is \$52,560,240. The project consists of the construction of a 510 bed jail facility in Porterville. The facility is a 2-story structure with the housing units having a tiered design. The facility includes support services for food, laundry, medical, video visitation, storage, administration, and program space.

For this change order, there are a total of thirteen (13) proposed change orders (PCO) that have been accepted. The PCO's are part of the construction process and are due to either conflicts in the plans or a required design change that was not anticipated by the Contractor at bid time. The following is a summary of the PCOs:
