

**COUNTY OF TULARE
SERVICES AGREEMENT
COURIER SERVICES**

THIS AGREEMENT ("Agreement") is entered into as of July 1, 2018, between the COUNTY OF TULARE, a political subdivision of the State of California ("COUNTY"), and PENINSULA MESSENGER SERVICE OF CENTRAL CALIFORNIA, INC., a business incorporated in California, ("CONTRACTOR"). COUNTY and CONTRACTOR are each a "Party" and together are the "Parties" to this Agreement, which is made with reference to the following:

- A. WHEREAS, COUNTY has invited proposals for Courier Services countywide; and,
- B. WHEREAS, CONTRACTOR has submitted such a proposal; and,
- C. WHEREAS, COUNTY and CONTRACTOR have reached agreement on all matters of negotiation with respect to COUNTY'S invitation and CONTRACTOR'S proposal and both desire to reduce the results of said negotiations to writing in the form of this Agreement.

THE PARTIES AGREE AS FOLLOWS:

1. **TERM:** This Agreement becomes effective as of July 1, 2018 and expires at 11:59 PM on June 30, 2023, with an option to extend for an additional three (3) year period by mutual written consent, unless earlier terminated as provided below, or unless the Parties extend the term by a written amendment to this Agreement.
2. **SERVICES:** See attached Exhibits A "Terms of Service"
3. **PAYMENT FOR SERVICES:** See attached Exhibits B and Exhibit B-1 "Cost Price Sheet". At the start of the second year and subsequent years there will be a 5.4% increase in the rates listed in Exhibit B-1.
4. **INSURANCE:** Before approval of this Agreement by COUNTY, CONTRACTOR must file with the Clerk of the Board of Supervisors evidence of the required insurance as set forth in the attached Exhibit C.
5. **GENERAL AGREEMENT TERMS AND CONDITIONS:** COUNTY'S "General Agreement Terms and Conditions" are hereby incorporated by reference and made a part of this Agreement as if fully set forth herein. COUNTY'S "General Agreement Terms and Conditions" can be viewed at <http://tularecountycounsel.org/default/index.cfm/public-information/>
6. **EXHIBITS:** CONTRACTOR shall comply with the terms and conditions of the Exhibits listed above, which are by this reference made a part of this Agreement.
7. **NOTICES:** (a) Except as may be otherwise required by law, any notice to be given must be written and must be either personally delivered, sent by facsimile transmission or sent by first class mail, postage prepaid and addressed as follows:

CONTRACTOR acknowledges that COUNTY has relied upon this representation and warranty in entering into this Agreement.

9. COUNTERPARTS: The Parties may sign this Agreement in counterparts, each of which is an original and all of which taken together form one single document.



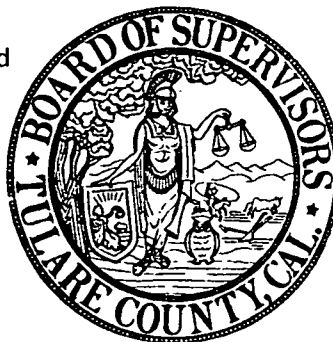

NON-PROFESSIONAL SERVICES INSURANCE REQUIREMENTS

CONTRACTOR shall provide and maintain insurance for the duration of this Agreement against claims for injuries to persons and damage to property which may arise from, or in connection with, performance under the Agreement by the CONTRACTOR, his agents, representatives, employees and subcontractors, if applicable.

A. Minimum Scope & Limits of Insurance

1. Commercial General Liability coverage of \$1,000,000 on an occurrence basis, including products and completed operations, property damage, bodily injury and personal & advertising injury (occurrence Form CG 00 01). If a general aggregate applies, either the general aggregate limit shall apply separately to this project/location (ISO CG 25 03 or 25 04) or the general aggregate, either the general aggregate limit shall apply separately to this project/location (ISO CG 25 03 or 25 04) or the general aggregate limit must be no less than \$2,000,000.
2. Insurance Services Office Form Number CA 00 01 covering Automobile Liability, (any auto) of no less than \$1,000,000 per accident for bodily injury and property damage. If an annual aggregate applies it must be no less than 2,000,000.
3. Workers' Compensation insurance as required by the State of California, with Statutory Limits, and Employer's Liability Insurance with limit of no less than \$1,000,000 per accident for bodily injury or disease.

B. Specific Provisions of the Certificate

1. If any of the required insurance is written on a claims made form, the retroactive date must be before the date of the contract or the beginning of the contract work and must be maintained and evidence of insurance must be provided for at least three (3) years after completion of the contract work.
2. CONTRACTOR must submit endorsements to the General Liability reflecting the following provisions:
 - a. *The COUNTY OF TULARE, its officers, agents, officials, employees and volunteers are to be covered as additional insureds as respects: liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts, or equipment furnished in connection with such work or operation.*
 - b. *For any claims related to this project, the CONTRACTOR's insurance coverage shall be primary insurance at least as broad as ISO CG 20 01 01 13 as respects the COUNTY, its officers, agents, officials, employees and volunteers. Any insurance or self-insurance maintained by the COUNTY, its officers, agents, officials, employees or volunteers shall be excess of the CONTRACTOR's insurance and shall not contribute with it.*
 - c. *Each insurance policy required by this agreement shall provide that coverage shall not be canceled, except with written notice to the COUNTY.*
 - d. *CONTRACTOR hereby grants to COUNTY a waiver of any right to subrogation which any insurer of the CONTRACTOR may acquire against the COUNTY by virtue of the payment of any loss under such insurance. CONTRACTOR agrees to obtain any endorsement that may be necessary to affect this waiver of subrogation, but this*

provision applies regardless of whether or not the COUNTY has received a waiver of subrogation endorsement from the insurer.

3. The Workers' Compensation policy shall be endorsed with a waiver of subrogation in favor of the COUNTY for all work performed by the CONTRACTOR, its employees, agents and subcontractors. CONTRACTOR waives all rights against the COUNTY and its officers, agents, officials, employees and volunteers for recovery of damages to the extent these damages are covered by the workers compensation and employers liability.

C. Deductibles and Self-Insured Retentions

Self-insured retentions must be declared and the COUNTY Risk Manager must approve any deductible or self-insured retention that exceeds \$100,000.

D. Acceptability of Insurance

Insurance must be placed with insurers with a current rating given by A.M. Best and Company of no less than A-VII and a Standard & Poor's rating (if rated) of at least BBB and from a company approved by the Department of Insurance to conduct business in California. Any waiver of these standards is subject to approval by the County Risk Manager.

E. Verification of Coverage

Prior to approval of this Agreement by the COUNTY, the CONTRACTOR shall file with the submitting department, certificates of insurance with original endorsements effecting coverage in a form acceptable to the COUNTY. Endorsements must be signed by persons authorized to bind coverage on behalf of the insurer. The COUNTY reserves the right to require certified copies of all required insurance policies at any time.

EXHIBIT A
TERMS OF SERVICE

CONTRACTOR RESPONSIBILITIES

1. **CAPACITY.** Vendor shall agree to furnish personnel, equipment and services necessary for the pickup and delivery of interoffice mail, packages and boxes, printing orders, small furniture items, paper stock, copy machine supplies, maintenance supplies, and other items as required by the County, to and from various locations, delivery times and days are described in Exhibit B – County Departments and Locations.

1.1. All courier employees shall wear the contractor uniform. The uniform will be of a professional nature, with display of patch, badge and name tag.

1.2. All courier employees must be able to lift and carry cartons or materials weighing up to 70 pounds.

1.3. The courier must use enclosed vans, mini-vans, stations wagons, small or full size pickup trucks with camper shells that lock for the transport of all items.

1.4. All vehicles must be owned and maintained by the company.

1.5. All vehicles shall be licensed in accordance with the requirements of the State of California, and trained in the transport of confidential documents and dangerous, or sensitive materials.

1.6. LAB SPECIMEN TRANSPORT. The courier will be required to transport lab specimens.

1.6.1. Specimens may be frozen, refrigerated, or room temperature items.

1.6.2. Internal processes, including chain-of-custody, will require training.

1.6.3. Any additional certification necessary for the transportation of lab specimens will be reviewed with the vendor.

2. **SCHEDULE.** Delivery times and days are described in Exhibit B.

2.1. Unless otherwise indicated, all stops are Monday through Friday.

2.2. No pick up or deliveries shall be made before 8:00am or after 5:00pm.

2.3. Vendor will be allowed a delivery time tolerance of \pm 10 minutes from the approximate delivery times indicated, except in the case of lab specimen delivery. Lab specimens must be delivered at the prescribed time.

TERMS OF SERVICE

- 2.4. Laboratory specimens being transported to any lab must be delivered within 90 minutes of pickup.
- 2.5. Vendor shall agree to adjust pickup and delivery times or days, and add or eliminate pickup and delivery points upon one week prior notice given by the County.
- 2.6. County will provide a notice for one-time runs not on the routine delivery/pick-up schedule. This may require travel outside Tulare County.
