REQUEST(S):

That the Board of Supervisors:

- 1. Approve an agreement with Kings View Corporation for the Porterville Wellness Center, in an amount not to exceed \$533,000, effective from July 1, 2018 through June 30, 2019; and
- 2. Authorize the Chairman of the Board to sign three (3) copies of the agreement.

SUMMARY:

The Porterville Wellness Center is a community-based multi-service center that will provide services to Transitional Age Youth (ages 18-24), adults (ages 25-59), and older adults (ages 60+) with severe mental illness and/or severe emotional disturbance. The Porterville Wellness Center will provide a supportive environment offering choices and self-directed guidance for advancing/cultivating wellness and recovery through services such as peer support groups, educational guidance, vocational services, fitness, independent living skill development, and socialization.

The Porterville Wellness Center will provide services to at least 50 unduplicated consumers each month for the duration of the contract.

On March 2, 2016 the Tulare County Health & Human Services Agency (HHSA), Mental Health Branch, released a Request for Proposal (RFP) for the operation of the Porterville Wellness and Recovery Center. After reviewing the proposals, it was

recommended that the contract be awarded to Kings View Corporation and approved by the Tulare County Mental Health Board on June 1, 2016. Kings View has successfully operated the Porterville Wellness Center since opening its doors on May 30, 2017.

FISCAL IMPACT/FINANCING:

The maximum reimbursement for this agreement is \$533,000, which will be included in the Fiscal Year 2018/2019 budget. This agreement is funded with Mental Health Service Act, Community Services and Supports revenue. There is no net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year plan includes the Quality of Life initiative to promote and encourage the provision of quality supportive services for individuals of Tulare County. The Porterville Wellness Center will benefit residents of Tulare County by working to promote wellness, recovery, and resilience in the mental health community, and reducing the negative outcomes often associated with severe and persistent mental illness.
