

SUBJECT: Approve a Memorandum of Understanding between County of Tulare and Kaweah Delta Health Care District

REQUEST(S):

That the Board of Supervisors:

- 1. Approve a Memorandum of Understanding between County of Tulare and Kaweah Delta Health Care District retroactive from July 1, 2017 through August 31, 2020. This Memorandum of Understanding is retroactive due to inadvertent delays in negotiations with Kaweah Delta Health Care District. It was impracticable for the Board to take action prior to July 1, 2017 due to the time needed to process, prepare, and submit the agenda item;
- 2. Find that the Board had authority to enter into this Memorandum of Understanding as of July 1, 2017 and that it was in the County's best interest to enter into the Memorandum of Understanding on that date; and
- 3. Authorize the Chairman of the Board to sign three (3) copies of the Memorandum of Understanding.

SUMMARY:

The purpose of this Memorandum of Understanding (MOU) is for Tulare County Health and Human Services, Mental Health Branch, to have a collaborative relationship with the Kaweah Delta Health Care District and place Psychiatric Residents at the Visalia Adult Integrated Clinic (VAIC) for completion of hours, and SUBJECT: Approve a Memorandum of Understanding between County of Tulare and Kaweah Delta Health Care District DATE: June 26, 2018

experience needed. These Psychiatric Residents are medical school graduates in need of completing their residency-required, patient-related and non-patient related training. VAIC is the largest adult clinic in Tulare County, serving over 1,700 consumers annually. By providing, education and training to District Residents, the County is able to ensure Mental Health professionals in the area are providing adequate care to County mental health consumers.

This MOU has been approved as to form by County Counsel. The following terms deviate substantively from standard County boilerplate: (1) This is a multi-year MOU; (2) It includes mutual indemnification; and (3) Either party may terminate without cause with 30 days written notice.

FISCAL IMPACT/FINANCING:

There is no financial impact with this MOU.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year plan includes the Quality of Life initiative to promote and encourage the provision of quality supportive services for individuals in Tulare County. The County's five-year plan also includes training and community outreach as an initiative to promote and encourage mental health education and training for individuals in Tulare County. Placement of Kaweah Delta Health Care District Psychiatric Residents at Visalia Adult Integrated Clinic will assist in promoting quality supportive services as well as meeting training and outreach initiatives.
