

#### REQUEST(S):

- 1. Approve an agreement with Champions Alternative Recovery Programs, Inc. in an amount not to exceed \$181,900 for the term of July 1, 2018 to June 30, 2019 for juvenile behavioral health services, reentry services, and family programming.
- 2. Authorize the Chairman of the Board of Supervisors to sign four (4) copies of the Agreement.

### **SUMMARY:**

Champions Youth Substance Use Disorder (SUD) Treatment Programs address substance use disorders and strengthen families through comprehensive and collaborative services including case management, individual, group, and family counseling, drug and alcohol education, and child development and parenting. Program perform complete intakes and psychosocial assessments for each client utilizing the Teen Addiction Severity Index (TASI). Assessments include medical histories, drug use histories, legal, vocational, educational, and mental health information.

Furthermore, Champions Youth SUD Treatment programs provide linkage and referral services to additional substance use and mental health treatment programs at Champions and other community-based providers, as well as linkage to our collaborative networks that provide housing, food, clothing, and

transportation for those in need.

#### FISCAL IMPACT/FINANCING:

There is no net County cost involved with this agreement. The cost of the program is covered entirely with JJCPA-YOBG funds; is not to exceed \$181,900 and is included in the Tulare County Probation Department's Fiscal Year 2018/19 proposed budget.

#### **LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:**

The County's five-year strategic business plan includes the Safety and Security initiative that provides for the safety and security of the public. The approval of this agreement helps fulfill this initiative by contracting with Champions Alternative Recovery Programs, Inc. for community-based treatment services designed to improve the quality of lives and reduce recidivism.
