Approve an Agreement with Central Valley Recovery Services.

REQUEST(S):

That the Board of Supervisors:

- 1. Approve an Agreement with Central Valley Recovery Services in the amount not to exceed \$350,000, to provide offenders recently realigned under state legislature with residential treatment, training services, and outpatient services, for the term of July 1, 2018 to June 30, 2019.
- 2. Authorize the Chairman to sign five (5) copies of the Agreement.

SUMMARY:

Central Valley Recovery Services (CVRS) is a non-profit, community-based facility that provides residential and out-patient substance abuse treatment for adult felony offenders. Referrals include individuals subject to Post-Release Community Supervision, in addition to individuals placed on Mandatory Supervision or Formal Probation pursuant to Sections 1170(h) and 1203 of the Penal Code. CVRS is committed to providing treatment and case management services in an effort to break the course of addiction, improve the quality of lives, and reduce recidivism.

SUBJECT: Approve an Agreement with Central Valley Recovery Services.

DATE: June 26, 2018

The Probation Department has an established relationship with Central Valley Recovery Services, who have received referrals and provided treatment interventions to adult offenders since October 10, 2011. These services were originally provided under the umbrella of a Professional Services Agreement.

FISCAL IMPACT / FINANCING:

The anticipated cost for services during Fiscal Year 2018/2019 is \$350,000, which will be included in the FY 2018/2019 budget. The costs associated with the agreement are offset by revenue received from SB 678 and AB 109. There are no net county costs.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic business plan includes the Safety and Security initiative that provides for the safety and security of the public. The approval of this agreement helps fulfill this initiative by contracting with Central Valley Recovery Services for community-based treatment services designed to improve the quality of lives and reduce recidivism.
