

SUMMARY:

Strategic Management System

The proposed 2017 Community Improvements Project – Phase 3 supports the strategic management approach to the utilization of Measure R Local Transportation funds which align with the Board of Supervisors (BOS), County Administrative Office (CAO), and the Resource Management Agency's (RMA) strategic goals and mission.

Notably, RMA's Strategic Management System is based on a "business model," by which proactive management and project delivery creates "public value."

Through the 2017 Community Improvements Project – Phase 3, public value can be measured as improvements to the roads and pedestrian facilities utilized by members of the respective communities.

2017 Community Improvements Project – Phase 3

The 2017 Community Improvements Project – Phase 3 (the Project) consists of improvements in the communities of Ivanhoe and Goshen. This project is a combination of two projects previously approved by your Board in the 2017 County Transportation Improvement Program (2017 CTIP).

Provided below is a summary of the two project locations.

- Location 1 Azalea Avenue and Road 159, Ivanhoe
- Location 2 Avenue 308 between Dollarhide Road and Effie Drive, Goshen

Improvements at Location 1 (Ivanhoe) include pavement resurfacing and concrete improvements such as curb, sidewalk, ADA curb ramps, and drive approaches along Azalea Avenue and Road 159. The proposed work along Road 159 is strategically coordinated through a partnership between Tulare County and the Ivanhoe's Boys & Girls Club; the County provided the design for the sidewalk improvements along Road 159, and the Boys & Girls Club constructed the improvements in accordance to the plans developed by the County. As part of the Project, the County will perform all necessary drainage tie-ins along Road 159.

Improvements at Location 2 (Goshen) include approximately ¼ of mile of street improvements along Avenue 308 from Dollarhide Road to Effie Drive. Improvements along Avenue 308 include pavement work, slurry seal, and concrete improvements such as curb, sidewalk, ADA curb ramps, and drive approaches.

In accordance with the California Environmental Quality Act (CEQA), the County has also determined that two categorical exemptions: State CEQA Guidelines (14 Cal. Code Regs.) Section 15300.4 Application by Public Agencies and Section 15301 Existing Facilities; respectively, are applicable to the proposed action.

The Plans and Specifications for the 2017 Community Improvements Project – Phase 3 are complete and ready to be approved by the Board of Supervisors.

SUBJECT: Authorization to Bid 2017 Community Improvements – Phase 3 Project June 26, 2018

Construction is anticipated to begin Summer of 2018.

Funding for the 2017 Community Improvements Project – Phase 3 is 100% funded from Measure R Local Program funds that are allocated to Tulare County.





Description of Nature, Purpose, and Beneficiaries of Project:

The improvements at Location 1 (Ivanhoe) will include approximately 215 linear foot of curb and gutter with 5- to 8foot-wide sidewalk and 4-foot-wide asphalt concrete paveouts, asphalt grinding and replace areas, ADA ramps, driveways, fence relocation, and drainage improvements.

Location 2 (Goshen) will include approximately a quarter of a mile of street improvements along Avenue 308 from Dollarhide Road and Effie Drive. The improvements include approximately 1,541 linear foot of curb and gutter with 5-foot-wide sidewalk and 4-foot-wide asphalt concrete paveouts, asphalt grinding and replace areas, slurry seal, ADA ramps, driveways, striping and signage improvements.

Construction is anticipated to begin during the 2nd or 3rd Quarter of 2018.
