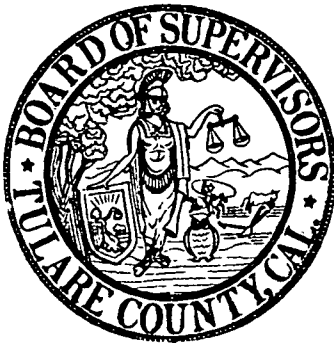

SUBJECT: Approve an agreement with Visalia Unified School District.

REQUEST(S): VUSD

That the Board of Supervisors:

1. Approve an agreement with Visalia Unified School District in an amount not to exceed \$128,000 to provide instructional services to Tulare County inmates for the period of July 1, 2018 to June 30, 2019.
2. Authorize the Chairman of the Board to sign three copies of the Agreement.

SUMMARY:

The Sheriff's Department has contracted with Visalia Unified School District (VUSD) since June 30, 1994, to provide instructional services to inmates. Classes currently being provided by Visalia Unified School District include General Equivalency Diploma (GED) and English Language Development (ELD).

Educational classes are essential to the successful transition back into the community. These classes are in alignment with our reentry plan, assessing the risk and needs of the inmates and developing a discharge plan which addresses employment, housing and education.

A prior agreement, identical except for time period, was approved as to form by County Counsel on August 11, 2017. There were no substantive deviations from the standard County boilerplate identified in the prior agenda item. The proposed renewal agreement does not include any deviations from the standard County

boilerplate. The only changes from the prior agreement is the time period of the agreement. The price for services has not changed.

FISCAL IMPACT/FINANCING:


This contract is not to exceed \$128,000 for Fiscal Year 2018/2019. Funds paid to Visalia Unified School District represent salaries, benefits, GED testing, and material costs for the program. The Inmate Welfare Trust Fund will reimburse the General Fund for this expenditure.

Visalia Unified School District will bill the Sheriff's Office quarterly. The bill will reflect the actual costs less the Average Daily Apportionment (ADA) that Visalia Unified School District receives from the State. Funds are included in the Sheriff's FY 2018/2019 operating budget. There will be no net County cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

This agreement is in alignment with the Quality of Life initiative of the Strategic Business Plan to encourage quality education opportunities.
