SUMMARY:

Tulare County Sheriff's Office has provided law enforcement patrol services to the U.S. Army Corps of Engineers at Success Lake Recreation Areas for many years. Under this agreement, one Deputy Sheriff and patrol vehicle will be assigned to service the Success Lake Recreation Sites located within Tulare County. Law enforcement service days shall be on all applicable Thursdays, Fridays, Saturdays, Sundays, and Federal holidays falling within the performance period.

SUBJECT: Approve Agreement with the United States Army Corps of Engineers,

Success Lake Recreation Areas

DATE: June 26, 2018

The primary duties of the Deputy Sheriff will include answering calls for service, routine patrol, response to emergency calls, and investigation of criminal offenses occurring in the U.S. Army Corps Success Lake recreation, administration, and wildlife management areas.

The Success Lake Recreation Areas to be serviced under this agreement include:

- Park Headquarters (HQ)
- Dam and Lower Compound Outlet Works Area
- North and South Tule Campgrounds
- · Tule Day Use Area
- Tule Point Recreation Area
- · Rocky Hill Recreation Area
- Visa Point Recreation Area
- Wildlife Management Recreation Area
- Gill Cove Recreation Area
- Big Sycamore Trial and Old Rustlers Recreation Areas

The reimbursement amount covered by the Agreement is \$76,656 and is effective for the performance period of May 15, 2018 through May 14, 2019.

The Department would like to note that the United States Army Corps of Engineers has routinely used digital signatures in the last several years. The electronic signature on the Agreement is valid as an original signature.

FISCAL IMPACT/FINANCING:

Total revenue to be billed to the U.S. Army Corps of Engineers will not exceed \$76,656. Funds are included in the Sheriff's 2017/2018 and 2018/2019 operating budget. There is no net County cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Safety and Security Initiative to effectively and fairly investigate, arrest, prosecute, and punish individuals who engage in criminal behaviors. The agreement will help fulfill this initiative by allowing the Tulare County Sheriff's Office to provide normal emergency and unanticipated enforcement of civil and criminal laws of the State of California and of the County of Tulare on lands administered by the U.S. Army Corps of Engineers.
