

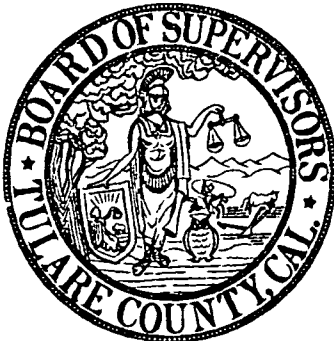

SUBJECT: Approve an agreement with Turning Point Youth Services, Inc.

REQUEST(S):

That the Board of Supervisors:

1. Approve an agreement with Turning Point Youth Services, Inc. for the provision of drug and alcohol recovery treatment services to Tulare County adolescents in an amount not to exceed \$642,350 retroactive from July 1, 2018, through June 30, 2019. This agreement is retroactive because the signed agreement was not received from the vendor until June 25, 2018. It was impracticable for the Board to take action prior to July 1, 2018, due to the time needed to process, prepare and submit the agenda item;
2. Find that the Board had the authority to enter into the proposed agreement as of July 1, 2018, and that it was in the County's best interest to enter into the agreement on that date; and
3. Authorize the Chairman of the Board to sign three (3) copies of the agreement.

SUMMARY:

Turning Point Youth Services, Inc. provides alcohol and drug treatment services to Tulare County youth and their families. The program focuses on treatment through individual and group counseling which may include drug education, recovery groups, anger management, parent support groups and gender specific groups.

In addition, Turning Point Youth Services, Inc. provides community recovery based services including participation in alcohol and other drug related community

prevention events, and character development activities.

This program operates under the regulations of the State of California Department of Health Care Services as outlined in Title 9 of the Administrative Code.

It is estimated that over 900 youth will utilize the services of Turning Point Youth Services, Inc. through this agreement in Fiscal Year 2018/2019.

This agreement did not include a Request for Proposal (RFP) process because Turning Point Youth Services has been a long-standing contractor for alcohol and substance abuse treatment.

FISCAL IMPACT/FINANCING:

Funding for this agreement in an amount not to exceed \$642,350 will be included in the Fiscal Year 2018/2019 budget. This agreement is paid through the Substance Abuse Prevention and Treatment Block Grant, Drug Medi-Cal, and Realignment funds. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative that encourages innovative provision of quality supportive services for at-risk adults, youth and children in state and federally mandated programs. This agreement increases the ability to fulfill that obligation by providing drug and alcohol recovery treatment services to Tulare County adolescents.
