

<u>SUBJECT</u>: Approve an agreement with Victor Treatment Centers, Inc.

REQUEST(S):

That the Board of Supervisors:

- Approve an agreement with Victor Treatment Centers, Inc., in an amount not to exceed \$110,000 for the provision of intensive mental health services to Tulare County minors retroactive from July 1, 2018, through June 30, 2019. This agreement is retroactive because the signed agreement was not received from the vendor until June 27, 2018. It was impracticable for the Board to take action prior to July 1, 2018, due to the time needed to process, prepare, and submit the agenda item;
- 2. Find that the Board had the authority to enter into the proposed agreement as of July 1, 2018, and that it was in the County's best interest to enter into the agreement on that date; and
- 3. Authorize the Chairman of the Board to sign three (3) copies of the agreement.

SUMMARY:

The Tulare County Health and Human Services Agency, Mental Health Branch, contracts with Victor Treatment Centers, Inc. (VTC), for Short-Term Residential Treatment Program (STRTP). These facilities provide specialty mental health services to Tulare County children and adolescents. VTC provides specialty mental health treatment modalities including the following services: assessment, plan development, individual and group therapy, medication support, case management,

and crisis intervention.

VTC STRTP's offer the highest level of care possible for Tulare County youth who are full-scope Medi-Cal beneficiaries or have been authorized by the Tulare County Resources Intensive Services Committee for admission. Additionally, all children and adolescents must be dependents of Tulare County Child Welfare Department or a ward of Tulare County Probation Department, and unable to be maintained in lower level care in California. Victor Treatment Centers, Inc., has facilities located in Stockton, Santa Rosa, and Redding, California. Through this agreement with Victor Treatment Centers, Inc., it is estimated that approximately 2-3 consumers will be served by this provider for Fiscal Year 2018-2019.

This agreement did not include a Request for Proposal process because VTC, is classified as a STRTP that offers the mandated mental health services for the County's high needs child welfare services and probation youth. Tulare County has access to a very limited number of STRTP's to serve this population, and additionally, has contracted with VTC for over fifteen years.

FISCAL IMPACT/FINANCING:

Funding for this agreement in an amount not to exceed \$110,000 will be included in the Fiscal Year 2018-2019 budget. These services are paid through Medi-Cal and Realignment revenues. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative that encourages innovative provision of quality supportive services for at-risk adults, youth and children in state and federally mandated programs. This agreement increases the ability to fulfill that obligation by providing intensive mental health services to Tulare County children and adolescents.
