#### REQUEST(S):

That the Board of Supervisors:

#### SUMMARY:

The Tulare County Sheriff's Department (Sheriff) receives AB109 funds from the State of California to assist with the education of inmates. The Sheriff wishes to continue to engage the Tulare County Library Department (Library) to assist in utilizing such funds by providing literary services to inmates. Funding provided will allow staff to provide two programs, Books Beyond Bars: Breaking the Barriers to Success and MotherRead/FatherRead Programs in the correctional facilities for a period of 12 months, with an option to renew every year depending on the availability of funds.

The successful programs provide tools to assist inmates to transition back into the community. Books Beyond Bars is a classroom program to assist inmates to improve their reading, writing, and math skills using short novels and basic math textbooks. MotherRead/FatherRead is a program to improve reading skills and promotes family literacy. Inmates are instructed in reading a children's book aloud. Once practiced the mother or father is recorded reading the book. The recordings are saved on a flash drive to be sent to their children for viewing.

The Library hired a full time Library Program and Literacy Services position to oversee this program. The Personnel Resolution was approved in October 2017 and is included in the FY 2018/19 Budget. This is a project service, limited term position filled as long as the MOU is in place and AB109 funding is available.

The Memorandum of Understanding (MOU) between the Sheriff and the Library is retroactive back to July 1, 2018, due to new staffing and program changes. Included as part of the program is the training of volunteers, curriculum preparation, fingerprinting and background checks, purchasing material, staff planning, and set up of technology and laptop computer. The Library continued the program on July 1, 2018 and hopes to renew the program again in FY 2018/19, depending on funding.

This MOU has been approved as to form by County Counsel. The following term deviates substantively from the standard County boilerplate: Either party may terminate without cause with 60 days written notice.

#### FISCAL IMPACT/FINANCING:

This MOU provides \$50,000 from the Sheriff's AB109 funds to the Library to provide Library Literacy Staffing (salary and benefits) and services (books and supplies) for two literacy programs in correctional facilities starting in FY 2018/19 and continuing depending on funding in future years. The expenses and revenues for this program are covered by AB109 funding There are sufficient funds budgeted for these services within the Fiscal Year 2018/2019 budget. No net County Cost.
