#### REQUEST(S):

That the Board of Supervisors:

- Approve a licensing agreement with Mischler Financial Group for their MaxQ online service.
- 2. Authorize the Chairman to sign four copies of the agreement.

#### **SUMMARY:**

The Treasurer's Office strives to find the most effective ways to manage the investment portfolio while ensuring transparency, enhancing controls and lower pricing. With this in mind, the Treasurer's Office is requesting access to the capabilities provided by Mischler Financial Group for their MaxQ online service.

MaxQ is an online cash flow and investment platform service to assist the Treasurer's Office with tracking current and future cash flows. Additionally, it compiles offerings from hundreds of broker-dealers providing information across thousands of fixed-income assets including federally insured certificates of deposits, new issue and secondary agency bonds, treasuries, corporate and municipal securities.

MaxQ would enable staff to maximize the amount of cash being invested, which would increase overall earnings. As a result pool participants will realize greater investment returns. MaxQ will also be another source of current market pricing and provide real-time access to the fixed-income market.
