SUBJECT: Approve an agreement with Kings View Corporation

REQUEST(S):

That the Board of Supervisors:

1. Approve an agreement with Kings View Corporation for South County One-Stop Center in an amount not to exceed \$700,000 to provide mental health services retroactive from July 1, 2018, through June 30, 2019. This agreement is retroactive due to an inadvertent omission in submitting the agreement timely for processing and because services have been provided since July 1, 2018. It was impracticable for the Board to take action prior to July 1, 2018, due to the time needed to obtain signatures, and to process, prepare, and submit the agenda item;
2. Find that the Board had the authority to enter into the proposed agreement as of July 1, 2018, and that it was in the County's best interest to enter into the agreement on that date; and
3. Authorize the Chairman of the Board to sign three (3) copies of the agreement.

SUMMARY:

The Tulare County Health and Human Services Agency, Mental Health Branch, collaborates with Kings View Corporation to provide mental health services through

the South County One-Stop Center under the Mental Health Services Act (MHSA) Community Services and Supports (CSS) component.

The South County One-Stop Center is designed to offer a wide array of integrated services to youth ages 12 to 15, and transitional age youth ages 16 to 25. The One-Stop program employs a Children's System of Care model that promotes the integration of mental health services and quality of life approaches such as employment, education, drug/alcohol counseling, and life skills training.

From July 1, 2018 through June 30, 2019 the program plans to provide services to 130 unduplicated consumers in addition to participating in community outreach and engagement opportunities.

Tulare County Mental Health Branch released a Request for Proposal (RFP) in 2013 for the South County One Stop. Through the proposal process, only one proposal was received. After review of the proposal, the RFP Review Team recommended Kings View be awarded the contract. Kings View has a long history of providing quality mental health services in Tulare County and has been providing these services continually since being awarded the initial contract in 2006.

This agreement has been approved as to form by County Counsel. The following term deviates substantively from the standard County boilerplate: 1) The State requires a 10-year records retention period for all Mental Health agreements superseding the County's 5-year retention period.

FISCAL IMPACT/FINANCING:

Funding for this agreement in an amount not to exceed \$700,000 will be included in the Fiscal Year 2018-2019 budget. This agreement is paid through Medi-Cal and MHSA revenues. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year plan includes the Quality of Life initiative to promote and encourage the provision of quality supportive services for individuals in Tulare County. Tulare County children and youth will benefit from the provision of mental health services by the South County One-Stop Center.
