SUBJECT: Approve an agreement with Kings View Corporation

REQUEST(S):

That the Board of Supervisors:

1. Approve an agreement with Kings View Corporation for South County Mobile Services in an amount not to exceed \$850,000 to provide mental health services retroactive from July 1, 2018, through June 30, 2019. This agreement is retroactive due to an inadvertent omission in submitting the agreement timely for processing and because services have been provided since July 1, 2018. It was impracticable for the Board to take action prior to July 1, 2018, due to the time needed to obtain signatures, and to process, prepare, and submit the agenda item;
2. Find that the Board had the authority to enter into the proposed agreement as of July 1, 2018, and that it was in the County's best interest to enter into the agreement on that date; and
3. Authorize the Chairman of the Board to sign three (3) copies of the Agreement.

SUMMARY:

The Tulare County Health and Human Services Agency, Mental Health Branch, collaborates with Kings View Corporation to provide mental health services through

the South County Mobile Services program under the Mental Health Services Act (MHSA) Community Services and Supports (CSS) component.

The South County Mobile Services program provides an integrated mental health service experience for all age groups with severe and persistent mental illness or serious emotional disturbance with emphasis on serving those traditionally unserved and underserved in the rural communities of South Tulare County. The Mobile Services strategy is intended to decrease barriers in accessing mental health services seen in rural communities. From July 1, 2018 to June 30, 2019, the program plans to provide services to 160 unduplicated consumers in addition to participating in community outreach and engagement opportunities.

Tulare County Mental Health Branch released a Request for Proposal (RFP) in May 2013 for the South County Mobile Unit. Through the proposal process, Kings View was the only organization to submit an application. The RFP Review Team recommended they be awarded the contract. Kings View has been providing quality services to the rural communities of Tulare County since being awarded the initial contract in 2006.

The agreement has been approved as to form by County Counsel. The following terms deviate substantively from the standard County boilerplate: 1) the State requires a 10-year records retention period for all Mental Health agreements superseding the County's 5-year retention period.

FISCAL IMPACT/FINANCING:

Funding for this agreement in an amount not to exceed \$850,000 will be included in the Fiscal Year 2018-2019 budget. This agreement is paid through Medi-Cal and MHSA revenues. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year plan includes the Quality of Life initiative to promote and encourage the provision of quality supportive services for individuals in Tulare County. The South County Mobile Services program fulfills this initiative by making mental health services more accessible in rural areas, increasing the health and well-being of residents with mental illness and their family members.
