SUBJECT: Consolidation of Local Contests/Measures with the General Election held on Tuesday, November 6, 2018

REQUEST(S):

That the Board of Supervisors:

1. Approve the consolidation of the Local Contests/Measures, listed in Appendix A, with the General Election and any other election which may be held within the jurisdiction of said districts on Tuesday, November 6, 2018.
2. Approve the procedures to be used in the conduct of the consolidated election, and said consolidation shall adhere to the provisions set forth in Section 10400 and following of the Elections Code.
3. Authorize the Election Official to perform all necessary and required services to the aforementioned districts relating to the conduct of the Local Contests/Measures and General Election.
4. Agree that each individual district shall reimburse the County in full for the services performed in connection with these elections, upon presentation of a bill from the Election Official to the District.
5. Agree that the Election Official will prepare a certified statement of the results of the election and submit it to each governing body within 30 days of the election.

SUMMARY:

The Elections Official has received numerous requests for consolidation with the General Election to be held on Tuesday, November 6, 2018. Per the Elections Code, the Board of Supervisors shall approve consolidated local elections held on the same date as well as specific election services rendered to local cities, schools

and special districts. Approval of this request would permit the Elections Official to consolidate the local elections and render election services as requested.

The Election Official has and maintains the expertise, equipment, and staff to administer elections; such is not routinely maintained by local agencies, some of which are very small. The services provided to the local agencies are reimbursable to the County and shall be paid after being invoiced by the County.


FISCAL IMPACT/FINANCING:
