SUBJECT: Approve a lease/purchase agreement with Key Government Finance, Inc. for Cisco SMARTnet.

REQUEST(S):

That the Board of Supervisors:

Approve a lease/purchase agreement with Key Government Finance, Inc. in an amount not to exceed \$1,569,013.71 for licenses and maintenance of Cisco SMARTnet for the time period of September 11, 2018 through October 11, 2021.

SUMMARY:

The Information & Communications Technology (ICT) Department is responsible for purchasing and monitoring the hardware and software contracts for the information technology assets of Tulare County, including but not limited to the mainframe computer, the data center servers, network infrastructure components and Storage Area Network (SAN).

Maintenance and licenses for Cisco Smartnet had previously been purchased from a third-party vendor called Dimension Data. As Dimension Data has exited the public sector market, ICT will instead renew these services from a third-party vendor called Development Group, Inc. (DGI). Renewing these services through a thirdparty vendor provides the County with more than 10% in savings in contrast with the full retail cost. The Board approved Agreement Number 28285 (along with Resolution number 2017-0702 and 2017-0703) with DGI on August 29, 2017. The \$1,569,013.71 includes maintenance and licenses for the County Cisco Smartnet equipment. This covers VoIP phones used by County of Tulare Health & Human Services Agency, Human Services Agency-TulareWORKs Division, and Tulare

County Information & Communications Technology employees. Failure to approve this renewal could result in a collapse of the County's communication infrastructure. The total cost over a three (3) year period for the SMARTnet agreement is \$1,570,000. This is broken down into annual payments of \$523,004.57. This three year agreement allows us to see significant savings.

This agreement has been approved as to form by County Counsel. The following terms deviate substantively from the standard County boilerplate:

- Assignment—Under this agreement, Key Government Finance, Inc. may assign sell, or encumber all or any part of the agreement without County consent
- Indemnification—Under this agreement, the County of Tulare agrees to indemnify Key Government Finance, Inc.

FISCAL IMPACT/FINANCING:

The total cost for the three year period is not to exceed \$1,569,013.71 and will be paid in three yearly payments of \$523,004.57. The amount of \$\$165,479.07 is included in the FY 2018/19 budget and will be charged to account number 001-142-4030-7066 and 001-142-4032-7066. The amount of 357,525.50 is included in FY 2018/19 budget and will be charged to account number 071-090-2900-7043, and 071-090-2900-7021. No additional Net County Cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Safety and Security Performance Initiative to provide for the safety and security of the public. The ability of the County to maintain community safety and security is dependent on the ability to keep the network equipment operational and, when there is an issue, react to it quickly. The license and maintenance purchase gives us the ability to maintain the network.
