SUBJECT: Approve an Amendment to Agreement No. 28719 with Central Valley Recovery Services.

REQUEST(S):

That the Board of Supervisors:

1. Approve an Amendment to Agreement No. 28719 with Central Valley Recovery Services, retroactive from July 1, 2018 through June 30, 2019, adding a HIPAA Requirements exhibit and revising two other exhibits clarifying standards and services to be provided, with no change to the dollar amount of the original Agreement. This Amendment is retroactive due to the date the revisions were made to the exhibits.
2. Find that the Board had the authority to enter into the proposed Amendment as of July 1, 2018, and that it was in the County's best interest to enter into the Amendment on that date.
3. Authorize the Chairman to sign five (5) copies of the Amendment.

SUMMARY:

Central Valley Recovery Services (CVRS) is a non-profit, community-based facility that provides residential and out-patient substance abuse treatment for adult felony offenders. Referrals include individuals subject to Post-Release Community Supervision, in addition to individuals placed on Mandatory Supervision or Formal

SUBJECT: Approve an Amendment to Agreement No. 28719 with Central Valley Recovery Services.
DATE: September 18, 2018 - REVISED

Probation pursuant to Sections 1170(h) and 1203 of the Penal Code. CVRS is committed to providing treatment and case management services in an effort to break the course of addiction, improve the quality of lives, and reduce recidivism.

The Probation Department has an established relationship with Central Valley Recovery Services, who have received referrals and provided treatment interventions to adult offenders since October 10, 2011.

The purpose of this amendment is to add a HIPAA Requirement exhibit, which is necessary due to the Contractor's access to Protected Health Information. In addition, Reporting Standards and the Monitoring and Audit exhibits have been revised to clarify the County's expectations for the reporting standards and services to be provided, consistent with other County agreements for similar services.


FISCAL IMPACT / FINANCING:

The anticipated cost for services during Fiscal Year 2018/2019 is \$350,000, which will be included in the FY 2018/2019 budget. The costs associated with the agreement are offset by revenue received from SB 678 and AB 109. There are no net county costs. This amendment makes no changes to the dollar amount of the original approved agreement.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic business plan includes the Safety and Security initiative that provides for the safety and security of the public. The approval of this agreement helps fulfill this initiative by contracting with Central Valley Recovery Services for community-based treatment services designed to improve the quality of lives and reduce recidivism.
