SUBJECT: Lighting of the North Fork Bridge Event

REQUEST(S):

That the Board of Supervisors:

1. Approve the "Lighting of the North Fork Bridge" event to be held on November 16, 2018 thru January 3, 2019 in the community of Three Rivers; and
2. Approve the "Lighting of the North Fork Bridge" event to be an on-going event for future years until such time as conditions of the event and/or the location change, and subject to timely submittals of complete application for each annual event.

SUMMARY:

The Resource Management Agency (RMA) received an application from the Three Rivers Chamber of Commerce to hold the Lighting of the North Fork Bridge event in the unincorporated community of Three Rivers. The North Fork Bridge (County bridge) is located 150 feet northwest of the intersection of North Fork Drive and Sierra Drive (State Highway 198), see Attachment A for Vicinity Map.

The Lighting of the North Fork Bridge event consists of decorating the North Fork Bridge with seasonal decorative lighting which will commence on November 16, 2018. The North Fork Bridge will remain lit until January 3, 2019. All seasonal decorative lighting will be removed by January 3, 2019.

The Lighting of the North Fork Bridge event is sponsored and insured by the Three Rivers Chamber of Commerce. The Three Rivers Chamber of Commerce have submitted all required documents for the event.

SUBJECT: Lighting of the North Fork Bridge Event
DATE: October 30, 2018

This event will be conducted and managed by the Three Rivers Chamber of Commerce on County right-of-way. For this reason, no permanent structures (as part of the decorations) will be allowed on County right-of-way.

Temporary road closures will not be required for this event.

FISCAL IMPACT/FINANCING:


No Net County Cost to the General Fund.

RMA will not incur cost as all labor and materials for the Lighting of the North Fork Bridge event will be provided and managed by the Three Rivers Chamber of Commerce.

The County's five-year strategic plan includes the "Quality of Life" initiative to provide greater recreational and cultural opportunities.

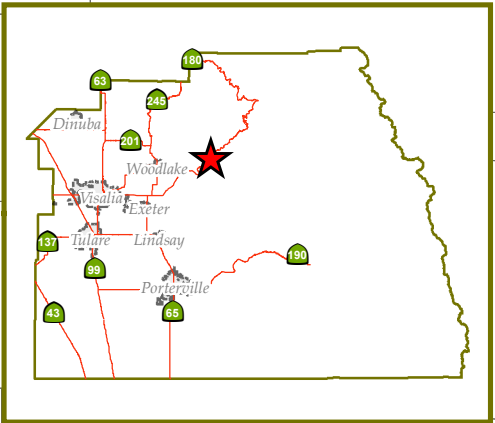
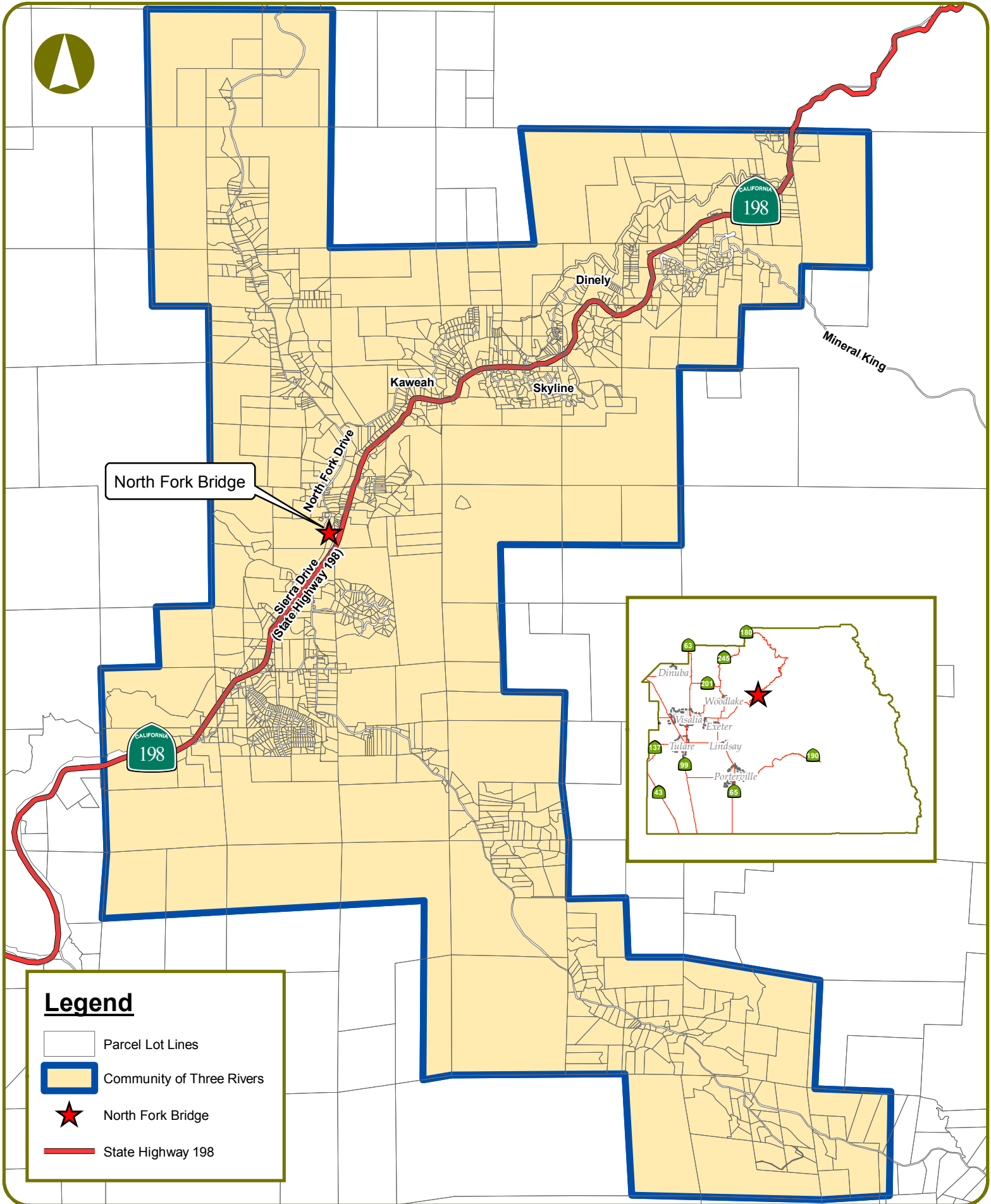
