SUBJECT: Linking to Employment Activities Pre-Release Grant

REQUEST(S):

That the Board of Supervisors:

1. Approve the budget adjustment of \$13,808 to increase the Workforce Investment Board of Tulare County (WIB) funding for services provided relating to the Linking to Employment Activities Pre-Release (LEAP) Grant (4/5ths vote required).

SUMMARY:

In October 2016, the Department of Labor (DOL) awarded the WIB a LEAP grant in the amount of \$500,000 to provide pre-release employment training services to Tulare County inmates. The WIB requested and was granted a term extension from DOL to December 31, 2018. The Tulare County Sheriff's Office (TCSO) is one of the partners for the grant. The DOL term extension requires additional funding of \$13,808 to TCSO for continued services.

FISCAL IMPACT/FINANCING:

The program is financed with federal funds. The WIB's operating budget will increase by \$13,808. There is no cost to Tulare County.
