Central Road Yard Maintenance Building Roof Project

REQUEST(S):

That the Board of Supervisors:

- 1. Authorize the Chairman of the Board of Supervisors to sign the Notice of Completion for the Central Road Yard Maintenance Building Roof Project.
- 2. Direct the Clerk of the Board of Supervisors to record the Notice of Completion for the Central Road Yard Maintenance Building Roof Project with the office of the Tulare County Recorder.

SUMMARY:

The roofing system of the Central Road Yard Maintenance Facility Building, located at 14001 Avenue 256 in Visalia, had reached the end of its serviceable life and was in need of an upgrade. Therefore, staff worked with Durham Construction Company, Inc. to develop a project scope and pricing for providing a 2-inch-thick Class II 3.0 density foam roofing system to cover and seal the existing metal building roof. On April 24, 2018, the Board awarded the project contract to Durham Construction Company, Inc. in the amount of \$219,757.25.

Durham Construction Company, Inc. was the awarded bidder of the National Joint Powers Alliance (NJPA) Job Order Contracting (JOC) contract. NJPA establishes and provides nationally leveraged and competitively solicited purchasing contracts under the guidance of the Uniform Municipal Contracting Law (M.S. 471.345 Subd. 15). The Joint Exercise of Powers Laws (M.S. 471.59) allow government entities to legally purchase through NJPA contracts without duplicating their own competitive bidding

process and requirements. The result of this cooperative effort is a high quality selection of nationally leveraged, competitively bid contract solutions. The JOC contract uses a unit price book or index to establish the pricing for a particular project or service. This allows awarding bodies to know the price they are getting up front on the awarded job, as well as, possible change orders if any arise.

The project consisted of the labor and material to clean and prepare the entire roof and apply the new foam roofing system. The project also includes a 15 year warranty on the new roofing system. The contract documents allowed 90 calendar days for completion of the construction. Work was substantially completed within the contract time, in July 2018, and within the designated budget; there were no proposed change orders for this project.

It is requested the Board approve the Notice of Completion for the Central Road Yard Maintenance Building Roofing Project.

FISCAL IMPACT/FINANCING:

The project is funded in the Resource Management Budget Line 014-225-2320-8146.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's Strategic Plan includes the Safety and Security initiative to provide for the safety and security of the public. The Central Road Yard Maintenance Building Roof Project aligns with the initiative by providing improved facilities for serving the public.
