Approval to accept the grant allocation of funds from Department of Health Care Services (DHCS) for the Homeless Mentally III **Outreach and Treatment Program**

REQUEST(S):

That the Board of Supervisors:

- 1. Approve to accept the grant allocation of \$309,000 from Department of Health Care Services (DHCS) for the Homeless Mentally III Outreach and Treatment Program, and
- 2. Approve the necessary budget adjustment in the amount of \$309,000 (4/5ths vote required).

SUMMARY:

Homelessness remains a serious and pervasive issue for communities throughout the nation. Recognizing the severity of this context, the State of California has made available a variety of new programs for counties to shape a tailored response to local homelessness.

The Homeless Mentally III Outreach and Treatment Program is one of the programs that provides flexible local funding to develop and implement outreach and treatment approaches for individuals experiencing or at risk of homelessness with serious mental illness. This program is administered through the Department of Health Care Services (DHCS), and allocates a one-time amount of \$309,000 to Tulare County, as authorized by SB840. On September 18, 2018, through Resolution Nos. 2018-0781 and 2018-0782, the Board approved the request to

participate in this program and apply for the grant funds. DHCS has approved Tulare County's application and the allocation of funding will become effective on December 31, 2018.

FISCAL IMPACT/FINANCING:

Upon approval to accept funding, the attached AUD308 form will be filed to adjust the budget to include the \$309,000 awarded one-time, received and expended through the 2018/2019 fiscal year from January 1, 2019 to June 30, 2019, and the 2019/2020 fiscal year. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's Strategic Business Plan includes the Quality of Life initiative to promote public health and welfare and encourage the provision of quality supportive services for individuals in Tulare County. Approval to accept the one-time allocation of \$309,000 will allow the County and other stakeholders to design a program providing for activities supporting the needs of vulnerable communities in Tulare County, and improve the quality of life of all residents.
