SUBJECT: Approve the “Earlimart Annual Christmas Parade”

REQUEST(S):

That the Board of Supervisors:

1. Approve the “Earlimart Annual Christmas Parade” to be held on Thursday, December 13, 2018 from 5:00 p.m. to 8:00 p.m. in the unincorporated community of Earlimart; and
2. Approve the “Earlimart Annual Christmas Parade” to be an on-going event for future years until such time as conditions of the event and/or the location change, and subject to timely submittals of complete application for each annual event.

SUMMARY:

The Resource Management Agency (RMA) received an application from the Earlimart Town Council to hold the Earlimart Annual Christmas Parade event in the unincorporated community of Earlimart. The Earlimart Town Council is sponsoring and insuring the event. Prior to processing of a permit, Applicant must submit all required documentation for a parade permit.

The Earlimart Annual Christmas Parade event will be conducted and managed on County right-of-way by the Earlimart Town Council. The route follows portions of the county roads shown in Attachment A. The event will commence at the corner of Avenue 56 and Church Street (Road 136), then proceed south on Church Street to Center Avenue, then proceed westerly on Center Avenue to State Street, then proceed northerly on State Street to Sutter Avenue, then proceed easterly on Sutter Avenue ending at the Earlimart Middle School parking lot.

SUBJECT: Approve the Earlimart Annual Christmas Parade
DATE: December 11, 2018

There will be temporary road closures for this event.

RMA will not incur cost as all necessary signing and traffic control are to be provided and managed by the Earlimart Town Council, the sponsor of the event.
