SUBJECT: Approve acceptance of additional funding from the Workforce Investment Board for Inmate Programs.

REQUEST(S):

That the Board of Supervisors:

- Approve the extension and budget adjustment from the Workforce Investment Board of Tulare County retroactive from September 1, 2018 to December 31, 2018 to provide pre-release job training services to Tulare County Inmates in an amount not to exceed \$13,808. The request is retroactive due to the delay from the U.S. Department of Labor to notify the Workforce Investment Board of their grant extension.
- 2. Find that the Board had authority to extend the pre-release training program for the period of September 1, 2018 through December 31, 2018, and that it was in the County's best interest to extend the program.
- 3. Approve the necessary budget adjustments per the attached AUD 308 (4/5ths vote required).

SUMMARY:

The Workforce Investment Board (WIB) of Tulare County applied for the Linking Employment Activities Pre-Release (LEAP 2) through Specialized American Job Centers (AJCS) grant with the U.S. Department of Labor (DOL) to retain services that identify and support LEAP 2 participants (Sheriff's inmates), and was provided grant funding. The term of the grant was from December 1, 2016 through June 30, 2018 when the expected funds would be exhausted. The Sheriff's Office and WIB

entered into a Memorandum of Understanding (MOU) for the grant funding from WIB to the Sheriff's Office Inmate Programs Unit to support the LEAP 2 program, Resolution No. 2017-0038, Agreement No. 27949.

A portion of the WIB grant funds were not used and WIB has requested the Sheriff's Office extend the LEAP 2 Program. WIB has provided the Sheriff's Office an additional \$13,808 to extend the LEAP 2 program an additional three months. The \$13,808 is for the performance period of September 1, 2018 through December 31, 2018.

Today, the Sheriff's Office request your Board approve the extension of the LEAP 2 program and MOU past its original term, to continue for the period of September 1, 2018 through December 31, 2018. The LEAP 2 program extension will be funded by WIB. If the grant obligations have not been met, the MOU allows for an extension past its original program termination date of June 30, 2018.

FISCAL IMPACT/FINANCING:

- The Sheriff's Office received \$85,779 for the originally agreed performance period of December 1, 2016 through June 30, 2018.
- The Sheriff's Office received an additional \$12,320 for the performance period of July 1, 2018 through September 30, 2018. This amount is reflected in Web Budget for FY 18/19.
- The additional funding to extend the LEAP 2 program will come from WIB in the amount of \$13,808 for a performance period of October 1, 2018 through December 31, 2018.

There is no net County cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The project meets the County's existing strategic business plan under the Safety and Security section by providing facilities and resources for training and rehabilitation of criminal offenders.
