SUBJECT: Approval of the Tulare County Council on Child and Youth Development Annual Certification Statement

REQUEST(S):

That the Board of Supervisors:

1. Approve the Tulare County Council on Child and Youth Development Annual Certification Statement regarding composition of the Local Planning Council for 2019; and
2. Authorize the Chairman of the Board to sign one (1) copy of the Certification Statement.

SUMMARY:

On June 18, 1998, Pursuant to the Statutes of 1997, Assembly Bill 1542, the Tulare County Board of Supervisors approved and established the Local Child Care Planning and Development Council (LPC). The LPC is composed of twenty-five members, thirteen members are appointed by Tulare County Board of Supervisors and twelve members are appointed by the Superintendent of Schools. Per legislative directive, the LPC membership is divided into five categories; Public Agency Representative, Community Representative, Consumer Representative, Child Care Provider and Discretionary Appointee. The qualifications of each member have been reviewed and that all members listed in the attachment meet the council representation categories as mandated under Assembly Bill 1542 (1997) and California Education Code section 8499.3.

SUBJECT: Approval of the Tulare County Council on Child and Youth Development Annual Certification Statement

DATE: December 18, 2019

It is the responsibility of the Tulare County Council on Child and Youth Development to determine the impact of increased numbers of working families on the local child care supply; to assess the unique child care and early education needs of each county; and to increase the availability and quality of such services. According to the 2015 needs assessment, the most recent available, the Tulare County Council on Child and Youth Development serves as an advocate for the child care needs of 104,291 children, ages 0-12, in Tulare County. The department has made a good faith effort to ensure the ethnic, racial and geographic composition of the LPC is reflective of the County's population.

The Tulare County Council on Child and Youth Development is mandated to submit the Annual Certification Statement to the state annually on January 15th. In the event that the priorities change from the previous year, the Tulare County Council on Child and Youth Development is mandated to hold a public hearing and submit the Annual Certification Statement to the Tulare County Board of Supervisors and Superintendent of Schools for approval prior to submitting them to the state. The Annual Certification Statement has been revised for 2019. The Tulare County Council on Child and Youth Development held a Public hearing regarding the Annual Certification Statement on November 1, 2018, which included the public posting of the hearing agenda 72 hours prior to the meeting as required by the Ralph M. Brown Act of California.

The Tulare County Superintendent of Schools has signed off on the form and it is recommended that the Tulare County Board of Supervisors approve and authorize the Chair to sign off on the Tulare County Council on Child and Youth Development 2019 Annual Certification Statement.

FISCAL IMPACT/FINANCING:

There is no cost associated with this Annual Certification Statement. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative that encourages quality education opportunities for all county residents. The Tulare County Council on Child and Youth Development fulfills this obligation by ensuring that the child care needs of all children are identified and met.



