<u>SUBJECT</u>: Accept the donation of a vehicle from the Ducor Telephone Company to the Tulare County Sheriff's Office.

REQUEST(S):

That the Board of Supervisors:

Accept the donation of a vehicle from the Ducor Telephone Company to the Tulare County Sheriff's Office for use in the Sheriff's Search and Rescue Unit, valued at \$2,139.

SUMMARY:

The Ducor Telephone Company (DTC) has declared their 1997 Ford Expedition SUV, license plate no. 3VKT742, vehicle identification no. 1FMU18L2VLB03604 as surplus. The vehicle has a metal track wheel system, rather than four tires. The vehicle tires have been replaced with a moving triangle shaped track, similar to that seen on a bulldozer, which takes the place of each tire. The track equipped vehicle can increase mobility in treacherous terrain such as rocks, snow, and mud. The vehicle would be an asset for the Sheriff's Office. The vehicle is in good working order and requires no repairs to make it immediately operational for the Sheriff's Office.

DTC contacted the Sheriff's Office to determine if the Sheriff's Office would have a use for the vehicle. The Sheriff's Office has determined that the vehicle would be an asset for various operations requiring such a vehicle. The vehicle will be assigned to the Sheriff's Search and Rescue Unit (SAR). SAR is composed of members of the Sheriff's Office who have specialized training to assist in incidents such as rescue's of injured or trapped individuals, or search for missing people, property, or evidence, and a host of other operations. SAR's components encompass all units

of the Sheriff's office to include our dive team, mounted unit, aircraft resources, unmanned ariel vehicles (drones), and boating, as well as outside agency partners. This vehicle will assist SAR by extending capabilities to unique response to community needs in our mountainous areas.

If approved by the Board, the Sheriff's Office will coordinate the vehicle transfer with County Purchasing. Additionally, the vehicle will be added to the County's capital asset system.

FISCAL IMPACT/FINANCING:

There will be no cost to the general fund. The vehicle will be registered as California "Exempt" and requires no DMV registration fee or title transfer fee.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Safety and Security Initiative to plan and provide coordinated emergency preparedness, response, recovery and mitigation capabilities for both natural and man-made disasters. This vehicle will be useful to increase the Sheriff's capability to provide assistance.
