Approve budget adjustments.

REQUEST(S):

That the Board of Supervisors:

Approve the necessary budget adjustments per the attached AUD 308's (4/5ths vote required).

SUMMARY:

The Sheriff's Office (TCSO) is requesting the following budget adjustments be made to the Sheriff's fiscal year 2018/2019 operating budget:

- Increase the revenue and expenditure budget for the Sheriff's Farm Program by \$60,000 to offset costs related to the farm hay barn. The current hay barn is approximately 30 years old. The roof must be replaced due to water leaking onto the hay. The hay barn will also increase in size due to the expansion of the farm over the last several years. TCSO is now growing more alfalfa; therefore, a bigger hay barn is needed. There is no net County cost to remodeled hay barn.
- Increase the revenue and expenditure budget by \$133,907 for State Criminal Alien Assistance Program (SCAAP) awarded by the U.S. Department of Justice. SCAAP provides federal payments to states and localities that incurred costs for incarcerating undocumented criminal aliens with at least one felony or two misdemeanor convictions for violations of state or local law, and incarcerated for at least four consecutive days during the reporting period. Agencies do not know how much their SCAAP award will be when they apply for SCAAP funding. The award is based on how many agencies

applied and how many undocumented inmates were incarcerated. The increase in revenue will be offset by expenses within maintenance, equipment and special department expenses incurred by the SCAAP program.

- Increase the revenue and expenditure budget for the Standards and Training for Corrections Programs (STC) from \$128,355 to \$137,340, a difference of \$8,985. STC is a voluntarily program that agencies participate in and are allocated subvention funding through the STC program. The increase in revenues of \$8,985 will be offset by an increase in training for Detention Staff. The final training allocation was not determined until October 29, 2018 and is based on the eligible budgeted positions that will require annual training and the required CORE training, therefore, a budget adjustment is necessary.
- Increase the revenue and expenditure budget for Fingerprint images for FY 18/19 by \$170,000. TCSO usually incurs 12 months of fingerprint fees each fiscal year, however, we will have 6 months of expenses that should have been posted in the prior fiscal year, FY 17/18. These are fees that are submitted to the California Department of Justice (DOJ) for processing the fingerprint images rolled by TCSO. In January of 2018, TCSO began utilizing Permitium, LLC for online concealed carry weapons applications. With this new process, the reconciling of fees to be remitted to DOJ took longer than anticipated. TCSO is getting current with the reconciliation process and will be back on target by having 12 months of expenditures for FY 19/20.

FISCAL IMPACT/FINANCING:

Each of the budget adjustments listed will not require a net County cost.

- The Farm hay barn remodel will be funded through the Sheriff's Trust Fund 526-Farm Expansion Fund revenue will be place into account line no. 001-240-2900-9295
- The US DOJ award for SCAAP revenue will be increased and placed into account line no. 001-240-2500-5220
- The STC revenue increase will be placed into account line no. 001-240-2500-9292
- The fingerprint expenditure fee will increase the departments other licensing and permits revenue and placed into account line no. 001-240-2100-4212

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:
