Approve an addendum to Memorandum of Understanding Agreement No. 28234 with Health Net Community Solutions, Inc., dba Health Net, County of Tulare to describe the responsibilities of the County and Health Net for coordination of Medi-Cal Alcohol and Other Drug services for plan members served by both parties under the Department of Health Care Services Medi-Cal Managed Care Program. This Memorandum of Understanding is retroactive to January 1, 2019, and will be in effect until terminated by either party. This Memorandum of Understanding is retroactive due to delays in the negotiation of terms. There is no cost associated with this Memorandum of Understanding;
2. Find that the Board had the authority to enter into the proposed agreement as of January 1, 2019 and that it was in the County's best interest to enter into the agreement on that date; and
3. Authorize the Chairman of the Board to sign two (2) copies of the agreement.

**SUMMARY:**  
The mission of the County of Tulare Alcohol and Other Drug (AOD) Services Department is to provide high quality, accessible, and cost-effective AOD care. The Managed Care Plan will provide and maintain responsibility for the treatment of

alcohol and drug health conditions, consultation services to providers about AOD health issues and treatment including medication consultation, and medical induced reactions from medications prescribed by the Managed Care providers. Upon approval, the Managed Care Plan will also provide hospital based ancillary services, clinical consultation and training. The department is requesting an addendum to the Memorandum of Understanding Agreement No. 28234 to add language that delineates the specific roles and responsibilities by Health Net and COUNTY for screening, referral, coordination and delivery of alcohol and other drug services for Health Net Medi-Cal beneficiaries.


**FISCAL IMPACT/FINANCING:**

There is no cost associated with this MOU, therefore, there is no additional net cost to the County General Fund.

**LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:**

The County's five-year strategic plan includes the Quality of Life Initiative that encourages innovative provision of quality supportive services for at-risk adults, youth, and children in state and federally mandated programs. This MOU increases the ability to fulfill that obligation by providing eligible clients with the screening, referral, and coordination and delivery of AOD health care services that would not otherwise be available.
