**<u>SUBJECT</u>**: Approve an agreement with Oaklandidence OPCO, LLC DBA Medical Hill Healthcare Center

# REQUEST(S):

That the Board of Supervisors:

- 1. Approve an agreement with Oaklandidence OPCO, LLC DBA Medical Hill Healthcare Center in an amount not to exceed \$360,000 (\$180,000 each fiscal year) for the provision of a Mental Health Rehabilitation Program effective from February 1, 2018 through June 30, 2019. This agreement is retroactive because services have been performed and due to inadvertent delays in obtaining the required signature pages and insurance documents from the vendor. It was impracticable for the Board to take action prior to February 1, 2018, due to the time needed to process, prepare, and submit the agenda item;
- 2. Find that the Board had authority to enter into the proposed agreement as of February 1, 2018 and that it was in the County's best interest to enter into the agreement on that date; and
- 3. Authorize the Chairman of the Board to sign two (2) copies of the agreement.

#### SUMMARY:

Oaklandidence OPCO, LLC DBA Medical Hill Healthcare Center in Oakland, California, provides skilled nursing mental health rehabilitation services for consumers of the Tulare County Health and Human Services Agency (HHSA), Mental Health Branch who are severely and persistently mentally ill. Their services are designed for consumers who require 24-hour supervision and are expected to benefit from

organized therapeutic treatment modalities that promote activities of daily living. Therapeutic treatment modalities may include behavioral interventions, quality of life skills, pre-vocational preparation, and alternative placement planning. Oaklandidence OPCO, LLC DBA Medical Hill Healthcare Center, strives to provide care and treatment to meet the needs of consumers and to maximize each consumer's health and functionality in a comfortable and supportive home-like environment.

Oaklandidence OPCO, LLC DBA Medical Hill Healthcare Center is one (1) of seven (7) out-of-county Skilled Nursing Facilities who will accept and provide treatment for Tulare County consumers who are in need of a higher level of care. In Fiscal Year 2017-2018, this facility served eighteen (18) consumers. In Fiscal Year 2018-2019 this facility is expected to serve approximately two (2) consumers per month for a total of twenty-four (24) consumers.

The agreement has been approved as to form by County Counsel. The following terms deviate substantively from the standard County boilerplate: 1) County must maintain records related to operation of contract for ten years from the date the record is created.

### FISCAL IMPACT/FINANCING:

The maximum amount of this agreement will not exceed \$360,000 (\$180,000 each fiscal year) and was included in the Fiscal Year 2017-2018 and is included Fiscal Year 2018-2019 budgets. These services are paid with realignment funds. There is no additional net cost to the County General Fund.

#### LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative that encourages innovative provision of quality supportive services for at-risk adults, youth and children in state and federally mandated programs. This agreement increases the ability to fulfill that obligation by providing higher levels of care in the least restrictive environment.
