# **SUBJECT**: Notice of Completion for Construction of the 2018 Road Repair and Accountability Act (RRAA) Project 1

#### REQUEST(S):

That the Board of Supervisors:

- 1. Accept the work for the construction of the 2018 Road Repair and Accountability Act (RRAA) Project 1 as complete by Agee Construction Corporation of Clovis, California; and
- 2. Authorize the Chairman to sign the Notice of Completion; and
- 3. Direct the Clerk of the Board to have the Notice of Completion recorded with the County Recorder.

#### SUMMARY:

This Notice of Completion is for the construction of the 2018 Road Repair and Accountability Act (RRAA) Project 1. This project was completed on schedule and within the allowable budget. The work was performed by Agee Construction Corporation under Tulare County Agreement No. 28502.

This project was approved by your Board on January 9, 2018 (Resolution No. 2018-0029). The lowest responsible bid was submitted by Agee Construction Corporation. On March 13, 2018, your Board awarded and approved (Resolution No. 2018-0173) a contract with Agee Construction Corporation of Clovis, California in the amount of \$3,041,556.

This project consisted of a combination of isolated pavement repairs followed by the installation of new asphalt surfacing, as well as full depth pulverization of existing asphalt material followed by the application of new asphalt surfacing.

Provided below is a summary of the roadway which received treatment as part of this project:

- Avenue 408 from Road 112 to Road 120
- Avenue 384 from Road 80 to Road 96
- Avenue 264 from State Route 99 to Road 100
- Road 100 from Avenue 264 to Avenue 276
- Road 158 from Avenue 296 to State Route 216
- Avenue 368 from Road 100 to Road 108

There were two Contract Change Orders (CCO) written for this project, with a net total savings to the County of \$1,731.65. The first CCO, in the net amount (credit to the County) of \$1,731.65, was written to compensate the contractor as set forth in the "Payment Adjustment for Price Index Fluctuations" clause of the Special Provisions and to credit the County for asphalt material outside of the allowable density range, but within contract acceptance, as specified in the project specifications. The second CCO was a zero-dollar change order to allow contract items to exceed the 125% threshold without the need to provide an adjustment to the contract item unit price.

An allowance of 5.41% of the contract bid amount, or \$164,577, was authorized for contingencies at the time of award setting the total approved contract amount at \$3,206,133.

The final project cost to complete this project was \$3,043,884.87 which is 0.08% above the bid amount and is 5.06% below the authorized contract amount plus contingencies.

This project has been completed in accordance with the plans and specifications and is now ready for acceptance by the Board.

The final project cost to complete this project was \$3,043,884.87 which is 0.08% above the bid amount and is 5.06% below the authorized contract amount plus contingencies.

This project was fully funded by the roads fund with revenue coming from the State Road Maintenance and Rehabilitation Account (RMRA), Local Measure R, and other State and Federal roads funding sources.


