- 3. Authorize the Chairman to sign the Project Certification form; and
- 4. Authorize the Chairman to sign the Notice of Completion; and
- 5. Direct the Clerk of the Board to have the Notice of Completion recorded with the County Recorder.

SUMMARY:

This Notice of Completion (NOC) is for the construction of the Earlimart Neighborhood Park Project. The work was performed by JT2, Inc. DBA Todd Companies under Tulare County Agreement No. 27896.

This project was approved by your Board on August 23, 2016 (Resolution No. 2016-0698). On November 15, 2016, your Board awarded and approved (Resolution No. 2016-0912) a contract with JT2, Inc. DBA Todd Companies of Visalia, California in the amount of \$2,477,983.99.

The completed project provided the residents of Earlimart with a community park including a soccer field, basketball courts, playground equipment covered by a shade

structure, landscaping, an irrigation system, flood control basin, and electrical upgrades. The soccer field is fenced off from the rest of the park and is utilized by the school while in session and open to the public after hours. The remainder of the park is available for public use at all times.

Due to unforeseen issues related to the construction of the project, change orders were required to complete the project in an amount that exceeded the approved contingency amount by \$26,117.60.

Staff Recommendation

This project has been completed in accordance with the plans and specifications and is now ready for acceptance by the Board. Staff recommends that your Board proceed with acceptance of the project and authorize the Chairman to sign both NOC (Attachment B) as well as the Project Completion Form (Attachment C).

FISCAL IMPACT/FINANCING:

The final cost to complete this project with adjustments for change orders is \$2,571,642.63. The County is currently withholding \$198,568.07 as liquidated damages.


