SUBJECT: Approve the “2019 Visalia Senior Games Event”

REQUEST(S):

That the Board of Supervisors:

1. Approve the “2019 Visalia Senior Games Event” to be held on Sunday, March 31, 2019 from 6:00 a.m. to 2:00 p.m. in Yokohl Valley; and
2. Approve the “2019 Visalia Senior Games Event” to be an on-going event for future years until such time as conditions of the event and/or the location change, and subject to submittals of complete application for each annual event.

SUMMARY:

The Resource Management Agency (RMA) received an application from the City of Visalia, Parks and Recreation Department (the City), to hold the 2019 Visalia Senior Games Event in Yokohl Valley. The City is sponsoring and insuring the event. Prior to processing of a permit, applicant must submit all required documentation for a Special Event Permit.

This event marks the City’s 4th Visalia Senior Games Event which is an Olympic-style competition for adults ages 50 and older. For the first three years, the events were held in Visalia. This year, the City is proposing an individual time trial cycling event to be held in Yokohl Valley for several reasons: there is less traffic in the area, it is a popular ride destination for cyclists, and the roads are in good condition. Overall, City staff believes Yokohl Valley will provide a safe and enjoyable location for the participants of the event.

SUBJECT: Approve the "2019 Visalia Senior Games Event"

DATE: February 26, 2019

The event will be conducted and managed on County right of way by the City. Temporary traffic control, including all necessary signage, will be provided at the event. The City must submit a traffic control plan to Tulare County for review and approval prior to the event.

Due to cell phone limitations in Yokohl Valley, the City will be working with the Tulare County Amateur Radio Club to relay information throughout the entire event. In addition, American Ambulance will be on-site throughout the event to provide first aid, advanced medical services, and transport should they be needed.

The route follows portions of Yokohl Drive as shown in Attachment A.

FISCAL IMPACT/FINANCING:

No Net County Cost.

RMA will not incur cost as all necessary signing and traffic control are to be provided and managed by the City of Visalia's Parks and Recreation Department, the sponsor of the event.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the "Quality of Life" initiative to provide greater recreational and cultural opportunities.

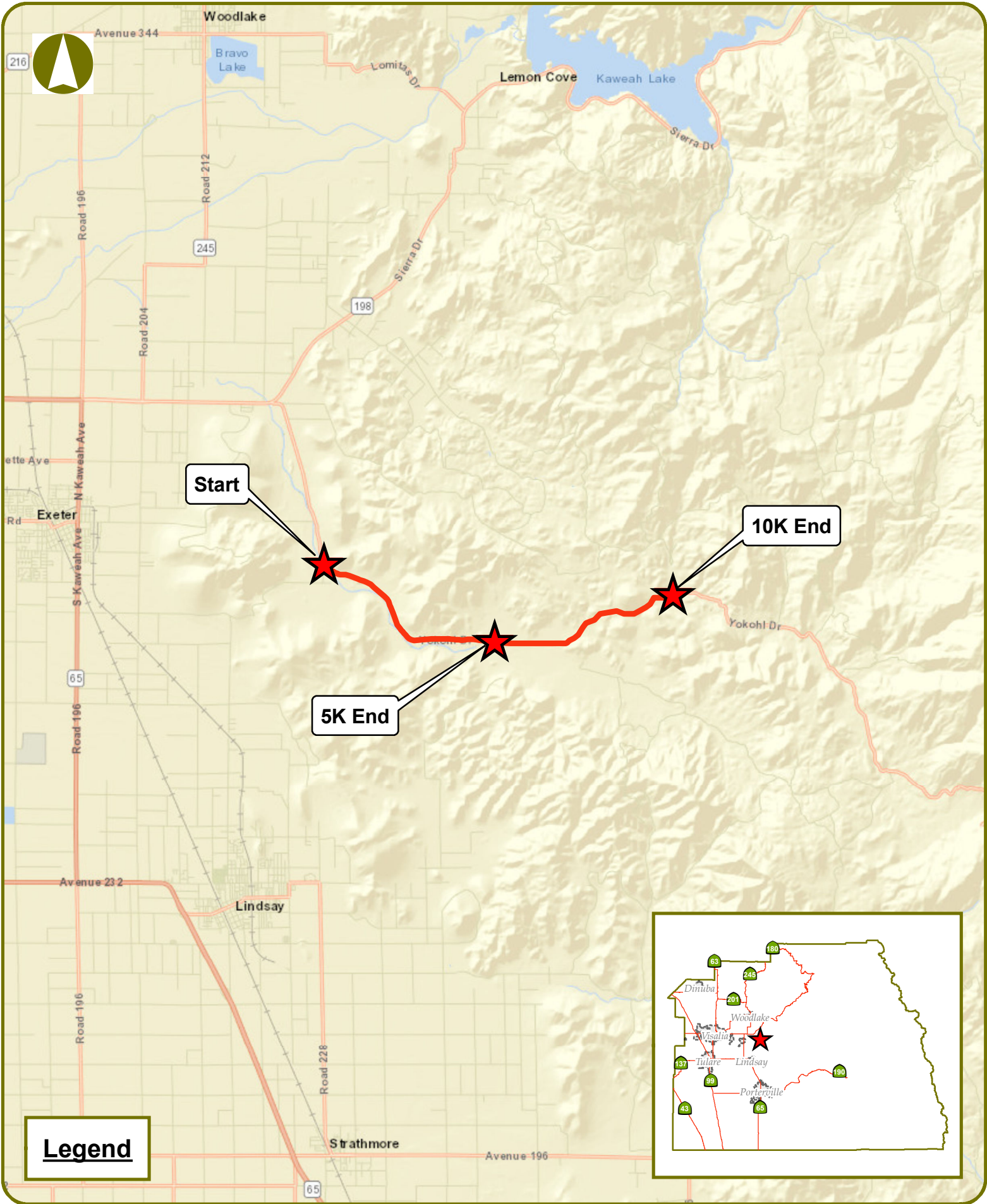
