REQUEST(S):

That the Board of Supervisors:

1. Accept the work for construction of the Cutler Park Well Replacement Project as complete by JT2, Inc. DBA Todd Companies.
2. Authorize the Chairman to sign the Notice of Completion.
3. Direct the Clerk of the Board of Supervisors to record the Notice of Completion for the project with the office of the Tulare County Recorder.

SUMMARY:

On September 13, 2016, the Board approved Agreement No. 27818 with JT2, Inc. DBA Todd Companies for the Cutler Park Well Replacement Project. The Project consisted of drilling a new 18-inch well to a depth of 600 feet. The contractor was required to provide all necessary items to provide a fully operational well.

Upon completion, the Cutler Park Well Replacement Project was inspected by the County Building Inspector and Capital Projects staff. The project has been completed in accordance with the project specifications and is ready for acceptance by the Board.

It is requested that the Board accept the work for construction of the Cutler Park Well Replacement Project as complete by JT2, Inc. DBA Todd Companies; authorize the Chairman of the Board of Supervisors to sign the Notice of Completion; and direct the Clerk of the Board of Supervisors to record the Notice of Completion for the project with the office of the Tulare County Recorder.

SUBJECT: Completion of the Cutler Park Well Replacement Project

FISCAL IMPACT/FINANCING:

The original contract amount was \$573,500. The final cost to complete this project was \$515,419.98. The County is currently withholding \$58,080.02 as liquidated damages.

The project was funded in Capital Projects Fund 030-086-3200-8125.
