**SUBJECT**: Countywide Bottled Water Program

### REQUEST(S):

That the Board of Supervisors:

- 1. Adopt the attached Mandatory Resolution for the continuation of the Countywide Bottled Water Program; and
- 3. Authorize and direct the Chairman of the Board to sign the Project Director Certification Form from the State Water Resources Control Board.

### SUMMARY:

The County has been implementing the Countywide Bottled Water Program since 2014 which provides emergency bottled water assistance to households with contaminated drinking water or dry wells. The County has received several funding agreements and amendments thereof for this program. The current agreement will expire on March 31, 2019. The County has requested a continuation of the bottled water program through an extension to September 30, 2020. This would allow the County's program to run parallel with Self-Help Enterprise, Inc. Point of Use Program which is also funded by the State Water Resources Control Board (SWRCB).

In order to continue the Countywide Bottled Water Program, the SWRCB has to switch funding sources which requires a new funding agreement rather than an amendment to the current agreement. The new funding agreement will be for \$200,000 and will expire on September 30, 2020. Additionally, a mandatory SWRCB Resolution has to be adopted and a Project Director Certification Form approved and signed submitted before this funding agreement will be finalized and signed by the SWRCB.

The grant will provide 10% or \$20,000 for grant administration to meet reporting requirements.
