SUBJECT: Tulare County Maintained Mileage of 2018

REQUEST(S):

That the Board of Supervisors:

- 1. Adopt that the maintained mileage was 2,972.82 miles as of December 31, 2018.
- 2. Direct the Clerk of the Board of Supervisors to return to the Resource Management Agency a certified copy of the resolution be filed with the State of California Department of Transportation.

SUMMARY:

The Tulare County Resource Management Agency is responsible for the maintenance of county roads in the Tulare County Maintained Mileage System. An annual report is required to be submitted to the State of California which includes the maintained mileage as of the end of the calendar year (2018) and which provides the changes to the maintained mileage from the prior year (2017). The annual report is required by Section 2121 of the Streets and Highways Code. The maintained mileage as of December 31, 2018 is 2,972.82. The summary of the maintained mileage of 2018 is shown in Attachment A - Tulare County Maintained Mileage of 2018.

FISCAL IMPACT/FINANCING:

Tulare County receives a portion of funding for roadway maintenance from the State for its maintained mileage, which is apportioned based on a variety of factors including number of registered vehicles in the County and the amount of mileage that the County maintains. Modifications to the maintained mileage in these relatively small amounts will have minimal net fiscal impact to Tulare County.

For the calendar year 2018, there were four exclusions to maintained mileage as follows:

The total of the above exclusions to the maintained mileage in 2018 is **1.39** miles.

The Tulare County Maintained Mileage of 2017 adopted by the Board of Supervisors by Resolution 2018-0216 was **2,974.21** miles.

Therefore, the Tulare County Maintained Mileage of 2018, as of December 31, 2018, was **2,972.82** miles.
